Remember:—ALL over 16 years of age must register on Saturday of this week, June 22nd. For Timmins, the place of registration is the public school, which will be open for the purpose from 7 a.m. to 10 p.m.

One of the most successful advertising "stunts" was pulled off at the Curtis Drug Store on Thursday evening. A window was filled with articles of various kinds, all retailing for a dollar or more, and many being worth as high as \$5.00. Each article was attached to a string and these strings were brought back over a bar and the customers drew a string from the bundle and pulled up his "draw" in this way. woman who supplied the liquor. The woman also made quite an exhibition when being arrested. As a consequence the woman was fined \$25 and costs while her partner escaped with the usual \$10 fine.

The woman was allowed out to get her fine, but went to Schumacher and got loaded again. Constable Raycroft picked her up and took her to South End in the evening, when the Magistrate's opinion was that she might better be sent down to serve the sentence imposed in the morning.

Mr. Ralph Elston's case against Mr. A. Booker charging the latter with allowing his dogs to run at large was dismissed. The Magistrate said that the evidence was so conflicting that he could reach no other decision than to dismiss the case, but if the complainant were dissatisfied with this he could try his luck in the Division Court. More evidence was submitted on Thursday by both sides. For Mr. Booker's side, several responsible witnesses gave evidence showing that the dogs were at the Mine at the time they were supposed to be down street, while for Mr. Elston's side there were respectable witnesses to swear to having seen the dogs at large, one witness having taken the numbers of their tags while they were on the street on the morning the chickens were killed. Mr. Booker's reply to the latter was that if the dogs were down street they were with him. There was also the evidence of Chief Wilson that there were another couple of dogs that were very similar in appearance to Mr. Booker's. Mr. Elston handled his own case very ably, while for Mr. Booker, Mr. Martin summed up the situation as one clearly of mistaken identity as to the dogs, the evidence, he pointed out, clearly establishing that Mr. Booker kept his dogs with him at the mine in the day time and locked in his yard at night.

ON June 22nd, Saturday, every man and woman, resident in Canada, who is 16 years and over, must attend at one of the places provided for registration, between the hours of 7 a.m. and 10 p.m., and there truthfully answer all the questions set forth upon the registration card. Upon signing the card, vouching for the accuracy of the answers, the man or woman will receive a Registration Certificate, as shown below, which must be carried upon the person thereafter.

Why the Certificate is so Important

For failure to register a maximum fine of \$100 and one month's imprisonment is provided, also an added penalty of \$10 for each day the person remains unregistered after June 22nd.

Persons remaining unregistered cannot lawfully be employed, and cannot draw wages for work done after June 22nd. Employers who keep unregistered persons in their employ will be liable for fines equal in amount to those recoverable from the unregistered employees.

Unregistered persons cannot lawfully purchase transportation tickets, and may find themselves

barred from travelling on railroads, steamboats, etc. Similarly they may be denied board and lodging at any hotel, restaurant, public house or boardinghouse.


In a word—All persons remaining unregistered, and all persons having dealings with unregistered persons, knowing them to be such, incur heavy penalties under the law.
