## I. W. W. VISITOR HERE GIVEN TWO YEAR TERM

John Toivar, Finnish American Brought I. W. W. Literature Into Camp

When the case of John Toivar, the Finnish American charged with bringing objectionable literature into the Porcupine Camp, came before Magistrate Atkinson on his last visit here, he pleaded guilty to the charge and made practically no defence of his actions or attitude. He had no lawyer and said he did not want any. Apparently his attitude was that he had been caught and the best plan was to simply take the consequences and say nothing. This is also the attitude taken by other I. W. W. agitators when they fall into the hands of the police in Canada. When Toivar was arrested here by Provincial Officer W. Moore and Officer R. Allen, it was on account of a large quantity of objectionable literature brought into the Camp. Toivar was taken in charge as he attempted to secure the illegal papers and pamphlets from the station. Enquiry developed the fact that Toivar was one of the executive officers of one of the I. W. W. lodges in the States, and apparently he had come here to secure the distribution of I. W. W. and Bolsheviki literature particularly among the alien elements in the district. Some sort of organization is busily at work at this disturbing procedure, there being several wholesale distributions occurring in the district recently. Toivar, however, gave little help in exposing anything he knew of the illegal organization or its methods or purposes. He is a Finnish-American quiet-mannered, well educated in many ways, and with a smooth superficial knowledge of economics. In sentencing Toivar to two years in jail, Magistrate Atkinson took opportunity to point out that it was not intended to allow agitators and sedition-mongers to come here and attempt to cause disturbances and unrest. Some of the literature brought in by Toivar was very flagrantly seditious while all of it was objectionable as tending to inflame the ignorant and unlettered to modes of action that would be unconstitutional and injurious to the country.

## SAVAL CERTAINLY SURPRISED SOMEWHAT

Mr. Saval Proux, an alien gentleman well-known in the past for his frequent and generous contributions to the town treasury, through the medium of police court fines, will this week have perhaps another chance, or maybe more, to do some more contributing. In any event he is out on bail and will be called upon tomorrow to face a charge of having liquor illegally. Other charges are also possible. For some time past Officer Collins had the idea that Saval had some liquor that he had access to and perhaps, Saval might be spreading this liquor around. After some quiet but clever work the Officer decided that Saval had some booze cached in a Pine street office where he acted as a sort of caretaker. Officer Collins hid himself a night or two in the building, but though the man apparently came around to do some tidying up he never went near the booze at nights. Officer Collins then decided he would try day-time watching. Accordingly he hid himself in the coal bin in the basement, seeing that the door was left carefully locked behind him. For hours he waited patiently but no one came along. Just as it seemed to look hopeless again, Mr. Saval opens the door with his own key and comes in. From behind some boxes the Officer says he took a can of high wines partly filled a bottle he had with him, went into the lavatory and completed the filling of the bottle from a water tap there, and then carefully concealed the bottle in his clothes. Just as he was putting the finishing touches to adjusting the bottle, Officer Collins came suddenly out from the coal bin. Saval was so astounded at his unexpected guest that he could hardly stand up straight. Even when he eventually landed at the cells he was still white from the surprise. Before Officer Collins took him away, however, he asked Saval to locate his cache of booze. As a result of some scratching in the sand under some boards on the floor a gallon can of high-wines was unearthed, in addition to the other partly-filled can.

The famous steamship on wheels, known as 110, saw to it that Monday was duly observed as Labor Day by a number of the boys at the Fire Hall and others. No. 110 is in the hospital but hopes are entertained that following surgical operations by Drs. Schlettler, Taylor, Robson and others recovery may eventuate in a few days. It is difficult to kill a Ford and particularly a Ford like 110, but the boys are doing their best.

## NOTES OF INTEREST ABOUT PORCUPINE PROPERTIES

Diamond drill hole No. 2 has been started on the Gold Reef. The result from the other recent diamond drill work are said to be eminently encouraging.

Dome Lake is taking on more and more men from week to week.

Report has it that the Porcupine Crown is considering the Moneta Mine as a possible addition to the company's holdings in the Camp.

A meeting of the V. N. T. is expected this month to see about future plans for the working of the properties held.

The local stock market has experienced great activity in the buying of the Porcupine-Tisdale Mine shares by people in the Camp. It is currently reported that outside interest (possibly New York investors) are seeking blocks of the stock and this report, together with the suggestion that would prompt such buying, has tended to the purchase of this stock by people in the Camp.

Another, current rumor suggests that the Mining Corporation is negotiating for the purchase of a controlling interest in the Thompson Krist.

## CHIEFLY ROUTINE WORK AT LAST COUNCIL MEET

The last meeting of the Town Council, held on Monday of last week was taken up chiefly with routine business. Acting Mayor A. Brazeau presided and Councillors Fogg, DeFeu and Newton were also present. The Treasurer was authorized to pay \$331.88 interest on debentures previously charged to H. A. Colson. Mr. Colson purchased some town debentures and was charged with interest for a greater length of time than he considered himself liable for. The question was before the Council on previous occasions and it was felt that Mr. Colson's protest was justified at least to the extent of the refund now provided for. The matter of tenders for sidewalks was left with the chairman of the Public Works Committee and the Town Engineer to deal with. On motion of Councillors Fogg and DeFeu, the recommendation of the chairman of the Water Works Committee and the Town Engineer that the sewerage pipe be enlarged on Birch street was approved. On motion of Councillors Newton and DeFeu it was decided to raise the allowance of Mrs. Potvin from \$50.00 to \$65.00 per month, and that if she can save any money by sending to Eaton's that she be paid cash instead of orders in town. The next regular meeting of the Council is scheduled for next Monday evening.
