SUCCESSFUL CONCERT FOR JEWISH RELIEF FUND

One Hundred Dollars Netted by Sunday Evening Concert.

With practically no opportunity for preparations or arrangement, a concert was staged for Sunday evening in the New Empire Theatre after the church services, the event having the double purpose of giving publicity to the campaign in progress this week for the Jewish War Relief Fund and of securing something towards the fund at the same time. The attendance was very large, the theatre being filled, and the neat sum of \$100.00 was realized from the collection at the door. The theatre management very kindly gave the use of the theatre for the cause. The Timmins Citizens' Band rendered several selections in front of the theatre before the time of meeting and their excellent music soon attracted a big crowd.

On account of the shortness of time for preparation the programme was not an extended one. Dr. J. A. McInnis, Mayor of Timmins, presided, and in his opening address outlined the objects of the campaign. The Canadian Jewish War Relief, he pointed out, was a humanitarian organization now engaged in giving relief and aid to the suffering peoples of central and western Europe. There was the greatest possible suffering and privation existing in central and western Europe, following the ravages of the war. He referred to the horrors of the situation, as outlined in the newspapers and from other sources. Humanity could not stand by and see these people die for want of food and clothing. He thought it was particularly up to Canada and the United States from their present prosperity to assist the sufferers in Europe. The Canadian Jewish War Relief was doing a noble work. It considered no race or creed in its good work, and it should have the whole-hearted and sympathetic support of all in its work for humanity. Dr. McInnis referred particularly to the sufferings of the women and children, and asked for the people of Timmins to give all they could to relieve the situation.

Rev. J. D. Parks, pastor of the Timmins Presbyterian Church, was the only other speaker. He made out an effective case for the strongest and most earnest support from all to the Canadian Jewish War Relief. Referring to the children in the audience before him, he said that in Europe just such dear children were starving to death at present. In Central and Western Europe there were thousands of children, who not only had no such pleasures as motion picture entertainments, but to-day lacked even food and clothes. There were children five or six years old who did not even know the taste of milk, that article beyond the means of all poor people since the war began. There were thousands of orphans and helpless people to be earned for. "If you could only see the staring and suffering children I know you would give to the very limit." Rev. Mr. Parks went on to show that many million dollars would be required to provide for the suffering peoples of Europe, and he believed that all in Timmins only required to realize the need to respond with the utmost generosity. He referred to the broad and charitable basis on which the Jewish Relief was doing its great work for humanity, and on behalf of those who suffered he asked the people of Timmins to give as generously as they could that lives might be saved and children redeemed from want and starvation.

Dr. McInnis in announcing the Tag Days to be held on Monday and Tuesday of this week for the Canadian Jewish War Relief Fund, said he hoped the public would give generously as the need was great. The work of the Canadian Jewish War Relief had been endorsed by the leading statesmen of all the Allied Countries, and it was undoubtedly a noble, as well as a necessary work that was being carried on, without distinctions of race or creed, but all for humanity. Dr. McInnis also read from literature of the campaign to show how much could be done even with small contributions, in the way of saving lives and relieving want. "There are quite a few foreigners here to-night," said the Mayor, "and I want to make special appeal to them in this matter. Many of them come originally from the parts of Europe where the need is so great at present. Let them especially show generosity at this time in assisting the relief of their peoples overseas." The rest of the programme for the evening comprised high-class pictures. Two pictures were shown and both were much appreciated and enjoyed. Sunday evening's event made a good opener for the campaign that commenced this week for the Jewish War Relief Fund.

WOMAN PROSPECTOR BUILDING HOME IN NORTH.

Mrs. W. Brown, well known as a woman prospector in the North Land is building a bungalow for her own home at Swastika. Mrs. Brown, who came to the North Land from New York has done considerable prospecting work in the North Country and the old-timers often meet her on the trail. At present Mrs. Brown is specially interested in prospecting work on a property at Beatrice Lake. The building of the bungalow at Swastika suggests that she is planning to remain permanently in the North as one of the three or four women prospectors that are here.

IT COSTS SIX MONTHS TO KICK A POLICEMAN.

At the police court here last week Magistrate Atkinson impressed upon Steve and Bob Ruberick the evil of kicking a cop. He gave them each six months in North Bay jail to consider the matter further at the leisure of the state. Officer Bennett was taking an Austrian to the cooperina when Bob and Steve stopped him to tell him to stop. They started in to kick the officer and get the prisoner free, but Officer Bennett being Scotch held on to what he had. In the meantime Mr. Elliott of Schumacher happened along and with his assistance not only the original prisoner but the two who attempted to interfere with the police were safely locked up. Bob and Steve pleaded guilty to the charge of obstructing an officer in the discharge of his duty and they will have six months each of quiet communion in the North Bay jail to memorize the lesson that they should have better manners. Some drunks and disorderlies were fined at the same court, and much time taken up with the preliminary hearing of Geo. Breen on nine charges of theft from the Hollinger Mine, the articles said to be taken ranging from electric wire to brooms and axe handles. Breen was committed for trial on each of the nine charges and the cases will come up before the next session of the Supreme Court at Haileybury.

Income Tax Return

on or before the 30th of April, 1920

Dominion of Canada



Department of Finance

ALL persons residing in Canada, employed in Canada, or carrying on business in Canada, are liable to a tax on income, as follows:—

1. Every unmarried person, or widow, or widower, without dependants as defined by the Act, who during the calendar year 1919 received or earned \$1,000 or more.
2. All other individuals who during the calendar year 1919 received or earned \$2,000 or more.
3. Every corporation and joint stock company whose profits exceeded \$2,000 during the fiscal year ended in 1919.

Forms to be used in filing returns on or before the 30th of April, 1920.

ALL INDIVIDUALS other than farmers and ranchers must use Form T 1.

FARMERS AND RANCHERS must use Form T 1A.

CORPORATIONS and joint stock companies must use Form T 2.

Penalty

Every person required to make a return, who fails to do so within the time limit, shall be subject to a penalty of Twenty-five per centum of the amount of the tax payable.

Any person, whether taxable, or otherwise, who fails to make a return or provide information duly required according to the provision of the Act, shall be liable on summary conviction to a penalty of \$100 for each day during which the default continues. Also any person making a false statement in any return or in any information required by the Minister, shall be liable, on summary conviction, to a penalty not exceeding \$10,000, or to six months' imprisonment or to both this and imprisonment.

General Instructions.

Obtain Forms from the Inspectors or Assistant Inspectors of Taxation or from Postmasters.

Read carefully all instructions on Form before filling it in.

Prepay postage on letters and documents forwarded by mail to Inspectors of Taxation.

Make your returns promptly and avoid penalties.
