

BY-LAW No. 8

A BY-LAW OF THE BOARD OF TRUSTEES OF THE ROMAN Catholic Separate Schools for the Town of Timmins, to raise by way of loan the sum of \$26,000.00 for the purposes therein mentioned.

WHEREAS the Board of Trustees of the Roman Catholic Separate Schools for the Town of Timmins require to borrow the sum of \$26,000.00 to provide funds for the purpose of acquiring a school site in the said Town of Timmins and erecting a school building thereon, and for such purpose to issue debentures therefor, bearing interest at the rate of Six per cent. per annum, which is the amount of the debt intended to be created by this by-law;

AND WHEREAS it is expedient to make the principal of the said debt repayable in yearly sums, during the period of fifteen years, of such amounts respectively, that the aggregate amount payable for principal and interest in any year shall be equal as nearly as may be to the amount so payable for principal and interest in each of the other years;

AND WHEREAS it will be necessary to raise annually the sum of \$2,677.03 during the period of fifteen years to pay for said yearly sums of principal and interest as they become due.

AND WHEREAS the amount of the whole rateable property rateable for Separate School purposes in the said Town of Timmins, according to the last revised assessment roll, is \$1,085,180.00.

AND WHEREAS the amount of the existing debenture debt of the Board of Trustees of the Roman Catholic Separate Schools for the Town of Timmins is \$40,000.00 and no part of the principal or interest is in arrear.

NOW THEREFORE The Board of Trustees of the Roman Catholic Separate Schools for the Town of Timmins ENACTS AS FOLLOWS:—

1. That for the purpose aforesaid there shall be borrowed the sum of \$26,000.00 and debentures shall be issued therefor in sums of not less than \$100.00 each, bearing interest at the rate of Six per cent. per annum, and having coupons attached thereto for the payment of interest.

2. The debentures shall all bear the same date and shall be issued within one year after the date on which this by-law is passed, and may bear any date within such year, and shall be payable in fifteen annual instalments during the fifteen years next after the time when the same are issued and the respective amounts of principal and interest payable in each of the said years shall be as set forth in Schedule "A" hereto which is hereby declared to be and form part of this By-Law.

3. The debentures as to both principal and interest may be expressed in Canadian currency and may be payable at any place or places in Canada or Great Britain.

4. The Chairman of the said Board shall sign and issue the debentures and interest coupons, and the same shall also be signed by the Secretary-Treasurer of the said Board, and the debentures shall be sealed with the Corporate Seal of the said Board.

5. During fifteen years, the currency of the debentures, the sum of \$2,677.03 shall be raised annually for the payment of the debt and interest and said sum of \$2,677.03 shall be annually included in the yearly separate School rate to be levied and collected by the said Board for the said fifteen years, the currency of the said debentures, and the said sum of \$2,677.03 shall be levied and collected annually by a special rate sufficient therefor over and above all other rates in the same manner and form and from the like persons and property by, from, upon or out of which other Separate School rates are levied, raised and collected, for the said period of fifteen years.

6. The said sum of \$26,000.00 so borrowed and interest thereon and the said debentures shall be and the same are hereby made a charge upon the Schoolhouse property and premises and on the real and personal property vested in the said Board of Trustees of the Roman Catholic Separate Schools for the Town of Timmins, and upon all the Separate School rates of the said Board to be hereafter imposed until the said debentures and each and every of them, together with all interest thereon, shall have been fully paid and satisfied.

7. The said Debentures may contain any clause providing for the registration thereof authorized by any Statute relating to Municipal debentures in force at the time of the issue thereof.

COCHRANE WINS 3 to 2 IN 13-INNING STRUGGLE

Exciting District Game Here Last Wednesday. Cochrane's Win Popular in Town.

On Wednesday afternoon last in a regular N.O.B.A. fixture here Cochrane's string of victories remained unbroken. They won their fifth straight game, and deserved to win, though as much might be said also had Timmins won for it was anybody's game until the thirteenth innings.

The game started off in rather ragged and listless manner and developed into a pitcher's battle after the 3rd. innings. Glen Campbell on the mound for Cochrane was in trouble in the first three innings, as no less than 11 men were on bases in that time. He was lucky to escape with only two runs scored against him. Then he settled down and pitched a masterly game. Only five hits were gathered from his delivery after the third innings. The support behind him was of the choicest variety.

Thacker in right field pulled down Farr's fly that was labelled for two bases. G. Campbell in left field accepted three chances in nice style. Duncane, McLean at short accepted seven chances and his throwing was about perfect. He is about one of the best fielding short stops in the league, as he plays ball at all times and leaves the grandstand stuff alone. Don Campbell at third accepted four chances perfectly and contributed a double that developed into a run when Pierce dropped an easy throw that might have meant three men out.

Douglas, second baseman, featured with his hitting. He contributed a double and two singles. He also scored the run in the sixth that tied the score, and he crossed the plate with the winning run in the 13th, when he singled and scored on a sacrifice fly by Thacker.

Tate, pitching for Timmins, deserved a win as he pitched nice ball at all times and only walked one man, against his opponent's four.

Scully and Lake fielded in spectacular style, three of their catches especially pleasing the crowd. Destefano also made a circus catch and fielded nicely, but his performance was marred by his prize bone in the 13th that practically lost the game. Johnny wants to pay more attention to the game and less to the bush league crabbing and he will be the best short-stop in the league. He is a first-class all-around ball player, and all good sports are galled to think that he may be kidded into the bush league stuff.

From the spectators' viewpoint, Wednesday's game was one of the best. There was so much exciting ball that the crowd forgot to care who won. Cochrane boys are such good sports that their victory was a popular one. A victory for Timmins, of course, would have been even more popular, naturally. The Timmins team is generally believed to be superior to the Cochrane boys, and perhaps the answer lies in practice. Timmins team would not suffer a bit from more practice together as a team. There is generally from three to five players missing at all practices held lately and this does not give the team its best chance. With practice and team play Timmins can yet make them all sit up and take notice.

Cochrane—Allaire singled, G. Campbell flied to Destefano, Glen Campbell struck out, Acton did likewise. OR. 1H. OE.

Timmins—Scully out, Campbell to Acton, Farr out, Douglas to Acton. Duncane singled and stole 2nd. Sheehan struck out. OR. 1H. OE.

13. innings
Cochrane—Douglas singled, Morrison hit into a made to order double play. Destefano gunned it up by failing to touch the 2nd base. Douglas going to 3rd, when Destefano started to leave the field. Douglas scored on Thacker's sacrifice fly. D. Campbell out, Destefano to Pierce. 1R. 1H. OE.

Timmins—Tate singled and was out trying to stretch it to a double. Pierce out, McLean to Acton, McIntyre flied out to Allaire. OR. 1H. OE.
