BY-LAW NUMBER 69

FOR BORROWING THE SUM OF TEN THOUSAND DOLLARS (\$10,000.00) FOR THE PURPOSE OF ACQUIRING A SITE AND ERECTING THEREON A TOWN HALL AND FIRE STATION FOR THE TOWNSHIP OF CALVERT.

WHEREAS the Municipal Council of the Township of Calvert deem it expedient to borrow for the purpose of acquiring a site and erecting thereon a Town Hall and Fire Station, the sum of Ten Thousand Dollars (\$10,000.00).

AND WHEREAS in order thereto it will be necessary to issue debentures of the said Corporation for the sum of Ten Thousand Dollars (\$10,000.00) for the purpose of acquiring a site and erecting thereon a Town Hall and Fire Station as hereinafter provided, (which is the amount of the debt intended to be created by this By-Law) the proceeds of the said debt to be applied to the purposes aforesaid and to no other.

AND WHEREAS it is desirable to issue the said debentures at one time and to make the principal of the said debt repayable by yearly sums during the period of twenty years, being the currency of the said debentures, said yearly sums being of such respective amounts that the aggregate amount payable in each year for the principal and interest in respect of the said debt shall be as nearly as possible equal to the amount so payable in each of the other years of the said period.

AND WHEREAS the total amount required by the Consolidated Municipal Act, 1914 and amendments thereto to be raised annually by special rate for paying the said debt and interest as hereinafter provided is Eight hundred and seventy-one dollars and eighty-four cents, (\$871.84).

AND WHEREAS the amount of the whole rateable property of the Township of Calvert according to the last revised Assessment Roll thereof is Six Hundred and Thirty-two Thousand, One Hundred Dollars, (\$632,100.00).

AND WHEREAS the Township of Calvert has no debenture debt.

THEREFORE, THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF CALVERT,

Here and There

Gold production in Canada in 1922 passed the million ounce mark for the first time since 1902.

Public works to be undertaken in Vancouver this year will cost in the neighborhood of \$10,000,000, of which \$3,000,000 will be spent by the Canadian Pacific Railway on pier construction.

The Canadian Pacific steamship Montcalm carried 900 emigrants for Canada on her last voyage from Liverpool, the largest number of emigrants to leave that port this year.

Work was commenced last week on the new elevator at the Ballantyne pier, Vancouver, which will cost approximately \$2,000,000 to complete. The new elevator will have a storage capacity of 1,500,000 bushels.

Three thousand seven hundred licensed grain elevators in Manitoba, Saskatchewan, and Alberta have a total storage capacity of over 100,000,000 bushels. Ontario, Quebec and Maritime provinces have storage elevators with capacity up to 33,180,000 bushels.

VERT, enacts as follows:—

1. The Municipal Council of the Corporation of the Township of Calvert shall expend the sum of Ten Thousand Dollars (\$10,000.00) in the payment for purchasing a site and erecting thereon a Town Hall and Fire Station, and for the purpose of raising the said sums, debentures of the said Corporation to the amount of Ten Thousand Dollars (\$10,000.00) as aforesaid, (which is the amount of the debt intended to be created by this By-Law) in sums of not less than One Hundred Dollars (\$100.00) shall be issued on the fifteenth day of December, 1923; and shall be dated on the date of the issue thereof, and shall be payable within twenty years thereafter at the Royal Bank of Canada in Ansonville in the said Township of Calvert.

2. Each of the said debentures shall be signed by the Reeve of the said Corporation or by some other person authorized by By-Law to sign the same and by the Treasurer thereof; and the Clerk thereof shall attach thereto the corporate seal of the said Corporation.

3. The said debentures shall bear interest at the rate of six per centum per annum, payable yearly at the said bank, on the 15th day of December, in each and every year during the currency thereof, and shall have attached to them coupons for payment of the said interest, which coupons shall be signed by the Treasurer of the said Corporation.

4. During the Currency of the said debentures there shall be raised annually by special rate on all rateable property in the said Township of Calvert the sum of \$871.84 for the purpose of paying the amount due in each of the said years for principal and interest in respect of the said debt.

5. The debentures issued hereunder shall contain the provisions of Section 316, Sub-Section 1 of the Consolidated Municipal Act, 1914, as to transference of Debentures.

This By-Law shall come in force and take effect on the day of its passing its third reading by the said Municipal Council and an application shall be made to the Ontario Railway & Municipal Board for the confirmation of same.

EFFICIENT FREE SERVICE RE RESOURCES OF CANADA

A new catalogue of publications, just issued by the Natural Resources Intelligence Service, shows a number of useful maps, reports, and pamphlets, which that organization has prepared for the information of the investor, assistance of those engaged in commerce and industry, and guidance of the prospective settler. Economic maps illustrating progress along agricultural, commercial, and industrial lines; geographic maps of Canada, also the various provinces and districts; and interesting reports based on investigations made by the Service, comprise the collection of several hundred publications, that has been published to date.

The Service is a branch of the Department of the Interior, whose function it is to provide a central bureau of information respecting Canada's natural resources—a need to which public attention has frequently been drawn. Its work embraces a very broad field, necessitating the consolidation of much data gleaned from the evidence of explorers, corporation records, scientific and technical journals, and the reports of enquiries carried on by special commissions, universities, and other agencies. As the gathering and assembling of such information is only a means, towards an end, it must be put into such form as to shed light upon the practical problems of development enterprise, consequently much of the data is re-cast and transferred to standardized maps, reports, and pamphlets, which enable related groups of facts, to be furnished with the least possible delay.
