**ENGLEHART OPERATOR
COMMITTED FOR TRIAL.**

Joseph Gillice, the operator at Englehart at the time of the fatal accident at Dane last August was committed by Magistrate Atkinson for trial before a higher court. The defendant pleaded not guilty and elected to be tried before a Judge. There was no evidence taken, the official evidence at the inquest held in Englehart being filed with the court. Mr. W. A. Gordon appeared as counsel for the defence. The charge against Gillice is that of causing actual bodily harm in connection with the wreck. The evidence at the inquest suggested that the failure of Gillice to deliver certain orders received by him was more or less responsible for the wreck. Gillice is out on bail pending the trial before a Judge.

**SMALL POLICE COURT, IT
NETTED \$250 LAST WEEK**

There was only four cases at police court here last week, and one of these cases was a remand from the previous week, and was made into another remand to this week. This was the case of Mrs. Mary Boyehuk charged with immoral living and remanded for sentence. Solicitor Bull of North Bay was here last week on this case and is expected back again this week. Although at the trial the woman swore this was her first visit to Timmins, the police claim that she was convicted here before some years ago and sentenced to a term in the reformatory. Mr. Bull secured a remand to this week in the case. Magistrate Atkinson fined D. Alekna \$200.00 and costs for illegally having liquor. A. Barbas, for illegal purchase of liquor, was fined \$50.00 and costs. An assault charge was dismissed.

**BIG POLICE COURT FOR
THURSDAY OF THIS WEEK**

Usually Christmas Week is an easy week in the matter of police court, but not so this week. There is a big variety as well as a large number of cases for to-morrow (Thursday) to come before Magistrate Atkinson. In addition to remands from last week there will be a number of serious charges to be heard, most of them in connection with liquor. The cases, however, include one now listed as attempt to murder. This latter is a charge against a colored man just coming to town last week and giving the name of Sam Norman. He got into a dispute over the matter of a quarter, according to the story told the police, and proceeded to clean up the man who argued with him. A brother of the man attacked went to see fair play and this brother (A. Desormeaux) received a bad gash from a knife or razor, necessitating medical attention. He also had his coat cut in more than one place where the instrument used failed to reach him in its slashings.

There are two charges of selling liquor laid against John Graboski, following a visit of the police to his house last week. M. Clement will also face a charge of selling liquor. There is a charge of selling liquor to be answered by George Symnank. H. Russell, A. Tartan and Mrs. Wm. Cohen each will answer to charges of having liquor in a public place.

N. Pouff, the proprietor of a pool-room on Fourth Avenue, is charged with selling liquor, and Victor Ukalo with drinking in a public place as a result of a visit by Officers O'Connor, Martin, McCord and Simpson on Monday evening. They found a large quantity of liquor on the premises, together with a tester, funnels and other paraphernalia.

There are half a dozen drunks to answer to the roll call to-morrow. John Wirta will face the charge of having firearms while being an alien. A taxi driver who took on passengers in the prohibited area will be required to answer to the court.

Another taxi driver named Grenier will be charged with reckless driving. He ran into Mr. John Kilgore's auto standing near the station, smashing the mudguards and doing other minor damage. Then he beat it away and when followed and asked for an explanation he is said to have asked for a court case. Sometimes people get what they ask for around Christmas time.
