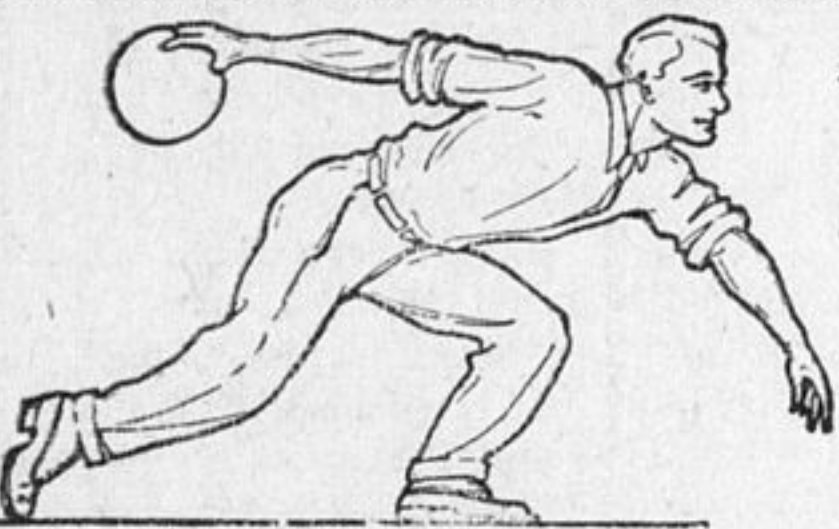

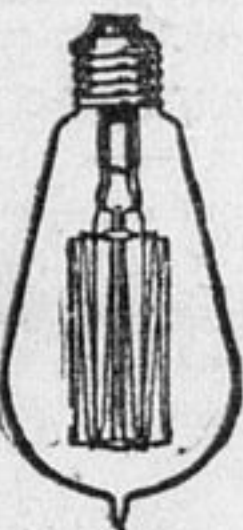

## OPENING GAME OF MINES LEAGUE WAS FAST HOCKEY

The hockey provided was also good. It even deserved a bigger attendance. As the games progress no doubt the attendance will increase, and it equally true that there will be also a growing improvement in the hockey played. Most people were delighted and delighted with the size of the crowd for the opening game. They were equally delighted with the fine line of speedy hockey dished up during most of the evening. The only regrettable feature of the evening was the incident in which Goal-tender Scully lost his temper and attempted to poke Goal Umpire Borland with the goal stick. The crowd liked the way the boys on the teams worked. Hollinger and Timmins teams alike were out to win, and worked. The result was a nice exposition of good hockey, with some speedy spots.

At 8:24 p.m., Mr. C. G. Williams, started the hockey season here going, when he faced the puck off in the Mines League Fixture, Timmins vs. Hollinger. Ross took the puck at the face-off and sent a hot one in on Bobby, who made a nice save. Roach went down, but shot wild, Lillie sending in another one right after. Carlin taking the puck and going down, sent in the first for the Gold Miners from a scramble in front of the Timmins net. Timmins pressed hard from the face-off, but rarely got through the Hollinger defence. Bobby made a nice save when he stopped the hot one from Gorman's stick, Roach taking the puck down, failed to pass Scully. The Gold Miners again tried a bombardment which Hoggarth was proof against. Portelance sending a weak one in on Scully, who cleared to Bowles, who went down through the Timmins defence but Hoggarth again saved. Individual play on both sides seemed to be the order, until Carlin and Boyd went down playing nice combination, losing at the Timmins defence. Campbell and Lillie went up to the Hollinger net, but Scully was not letting anything in. McDonald tried a rush, lost to Campbell, who in turn lost to Carlin, the big fellow calling on Bobby to save. Bowles started down when the gong rang, the score standing, Hollinger 1, Timmins 0.

The period opened with both sides trying to make a getaway, Gorman finally getting through, but shooting wild. Lillie went down but lost to Ross. The Gold Miners' trying one from outside the defence. Bowles drew the first penalty for slashing. Portelance started down, lost to McCoy. Campbell was hurt at this time and had to be carried off the ice, Gervais replacing him. Gervais tried hard from the start, and with Portelance played some nice combination. Carlin lost to Burns, who shot. Scully saved. ## MR. CHAS. SEE'S CANDY SHOP ROBBED BY HOLD-UP MEN.

Through the kindness of Mr. J. P. McLaughlin, formerly Mayor of Timmins, and now spending the winter in California; on account of Mrs. McLaughlin's health. The Advance is in receipt of a clipping from the front page of The Los Angeles Times giving an account of a bold robbery at Mr. Chas. See's Candy Shop. Mr. See was one of the old-time residents of this Camp and his many friends and acquaintances will be interested in the clipping. The Los Angeles paper says:—

"One of the most daring hold-ups in months in downtown Los Angeles occurred yesterday.

"A shabbily dressed man held up two girl clerks of the See Candy Shop, in the Metropolitan Theatre Building, Sixth and Hill streets. Hundreds of Christmas shoppers were passing by an open door only a few feet away.

"The robber walked back of the counter, pulled a revolver and ordered Miss Opal Robinson, the store manager, to open the cash register. She obeyed.

"Then forcing Miss Robinson and Miss Grace Davenport to stand back and keep quiet, the thief filled his pockets with all the bills, silver dollars, half dollars and quarters in the register.

"He left the smaller change, but in backing slowly out of the store the bandit picked up a piece of chocolate candy.

"Don't follow me," he said as he vanished in the crowd on the sidewalk.

"A hasty checkup of the cash made by the two badly frightened girls showed the robber had escaped with more than \$100.

"The robber was of medium height, thin, and wore a cap pulled down over his eyes. His coat collar was turned up. He was not masked.

"Both Miss Robinson and Miss Davenport are confident that they will be able to identify him. As soon as the robber disappeared the girls called the police.

"No customers were in the store when the robbery took place. The bandit was only three or four minutes in completing his call.

"Detectives and police officers, with full descriptions of the thief, were making every effort to capture the holdup man last night."

Carlin making a few nice saves Scully returned, and Gorman replaced him in the penalty box when he tripped Portelance, immediately after the latter was hurt and had to be carried off. Gervais came on in his place. Ross and McDonald tried some combination but Bob saved. Gorman tried another on Hoggarth who again saved. Don Campbell sent one in, but Scully saved. Ross and Bowles tried some combination but could not get through. The play was at the Hollinger end at this period, Gervais scoring in a scramble in front of the Hollinger net. The Miners protested and asked for the removal of the goal umpire. The game being resumed, both teams started to work hard, close checking being features on both sides, but the score was not increased, the game ending with the Hollinger one goal up.

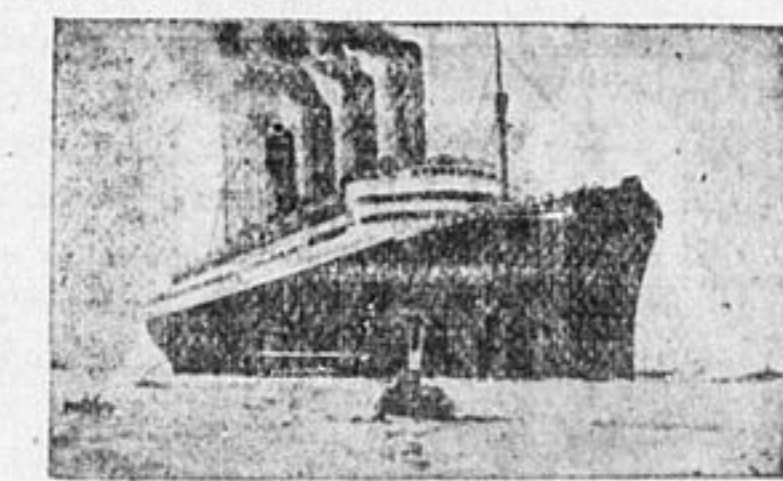
