The new development on the Quinze River is expected to come into operation by the 1st of September at the latest; the company's reservoirs, which have been extensively added to, are full, owing to the heavy rainfall in the latter part of last year, consequently there will be no shortage of water and from now on the company is assured of being able to take care of all demands for power.

The net earnings for January, 1924, amounted to \$64,168. The gross earnings for February are very satisfac tory, and it is expected that the net will show about the same as January. This monthly rate of net earnings has been maintained practically since September last when the Lower Sturgeon Falls development came into operation. The company's net earnings are now on a basis of over \$750,-000 per annum available for annual bond interest of \$292,500, and this is without any earnings from the Quinze development, which will deliver an additional 20,000 h.p. Upon the completion of this plant the capacity of the company will be as follows:



The Quinze development is capable of developing 60,000 h.p., and the additional 40,000 h.p. can be installed at a low cost owing to the fact that a great amount of the dead work necessary for the total installation is being done at the present time.

EX-POSTMASTER, KIRKLAND LAKE, GIVEN FIVE YEARS

Thos. P. Carr, former postmaster it Kirkland Lake, was sentenced last week by Magistrate Atkinson to five years in Kingston when he pleaded guilty to a charge of misappropriating post office funds. The amount involved was over \$7,000.00. This amount is said to have been taken in the course of a few months. The counsel for the defence, Messrs. 'H. L. Slaght and W. A. Gordon, made eloquent pleas for leniency, referring to the excellent character of the prisoner previously and his fine reputation for honesty and good citizenship. Prominent citizens of the district also testified to the previous good character of the accused man. Gambling is understood to have been the cause of the trouble, money being taken to cover losses until there was no chance for adjustment, the amounts involved reaching too large proportions. Crown Attorney Smiley agreed with much that the defence emphasized, but pointed out that the offence was a very serious one and the public had to be protected. He also mentioned the fact that no restitution had been made.

Before being taken to Kingston. Carr is being held at North Bay as an important witness in some gambling charges that have been laid against some Kirkland Lake men. It is said that the charge of using marked cards will figure in this case.

ENLARGED LAKE SHORE MILL READY EARLY IN MAY

According to an interview given last week by Mr. R. C. Coffey, manager of the Lake Shore Mine, at Kirkland Lake, the new and enlarged mill equipment will be in general operation early in May. The new crusher was placed in operation some days ago for a trial run, while the tube and ball mills are all in position and will be tuned up at an early date. Asked as to the probable capacity of the enarged mill, Mr. Coffey remarked that the plant would treat 300 tons of ore daily. As to this, however, it is obvious that the official announcement is extremely conservative. For instance, the two new 7x6 ball mills are capable of handling at least 175 tons each per day. In addition to these is the small 70-ton unit already in operation. A visit to the plant shows the ball mills to be about the smallest link in the process through which the ore is crushed and treated, and this makes it reasonable to believe that while a capacity of 300 tons daily is the aim of the management, yet there are good indications of this being exceeded by an additional 50 or 100 tons daily in due time. The mill \3 building on the Lake Shore has been enlarged sufficiently to accommodate one more ball and tube mill at such time as such an enlargement may be required. This will enable the management to increase the capacity to around 500 tons daily without any additional building other than for the accommodation of tanks. With the completion of construction work ! around the end of the coming month, the Lake Shore mill will be the fourth largest in the precious metal mining fields of Northern Ontario, ranking next to Hollinger, Dome and McIntyre-Porcupine. It is particularly important that since commencing milling operations over six years ago, the Lake Shore has produced an average of over \$24 from each ton of one treated. This is two and a half times richer than the average from the other leading gold mines of Northern


