FIREMEN OF NORTH LAND HONOUR MEMORY OF HERO

Secretary of Temiskaming Firemen's Association Tells of Recognition of the Late Gervais Sutherland.

The recognition given by the Temiskaming Firemen to the bravery of the late Gervais Sutherland, of Haileybury, who gave up his life in the Haileybury fire of 1922, is outlined by a letter from Mr. F. E. Thompson, Secretary of the Temiskaming Firemen's Association, in answer to a query by The Broke Hustler, of Iroquois Falls.

Mr. Thompson's letter follows:

At the meeting held in New Liskeard on Feb. 1st, 1923 the death of Fireman Gervais Sutherland was referred to and after some discussion as to ways and means of erecting a memorial, the President, Chief Caswell of Cochrane at that time, appointed a committee as follows: Chief Borland, Timmins; M. Smith, South Porcupine; J. H. Lever, New Liskeard; F. E. Thompson, New Liskeard and himself, to bring in report the following morning. The committee felt that a memorial which would be of some benefit to Mrs. Sutherland would be appropriate for after going into the matter very thoroughly it was found that he didn't even have any insurance. The town carry a blanket policy on their firemen, but as he had gone up to Kirkland Lake in July and stayed for a couple of months, he had been taken off the list and on returning had not been put back on.

After considering everything the committee felt that it should try and raise enough money to build a home for Mrs. Sutherland after finding that she owned a lot on Blackwall St. which is a very nice location. The committee reported the following morning as follows:

"We your committee on Sutherland Memorial report as follows that our Secretary be instructed to write to the chairman of the Northern Ontario Fire Relief Committee asking that this be considered a special case and that they at least double their donation of building material to Mrs. Sutherland.

Second, that the Secretary write to the Chairman of the Widows' Allowance Board asking that her's be considered a special case and that they increase their allowance to her.

Third, that all fire departments representing the Temiskaming Firemen's Assoc. raise whatever funds they can in whatever way they see fit in their respective towns and that the Association donate their \$100 Victory Bond.

Moved by W. H. Dawson, and seconded by H. H. Costain that the report of the committee be adopted. (Carried).

After considerable correspondence a double allowance of building material was received from the Northern Fire Relief Committee, but no consideration from the Widows' Allowance Board.

During the year the departments raised the following amounts: Timmins \$150.00; New Liskeard \$125.00; Schumacher \$100.00; South Porcupine \$100.00; Cochrane \$100.00; Haileybury \$100.00; Iroquois Falls \$50.00 and the Temiskaming Firemen's Assoc. \$100.00.

During the year with this amount and the assistance of the Haileybury Firemen a six-roomed bungalow was erected, but this was built up on posts and at the meeting held in South Porcupine on Feb. 7th, 1924, after Chief Merkley and F. E. Thompson had reported what had been done, the latter recommended that there should be a foundation under the house; should install plumbing and a pipeless furnace.

The president appointed Chief Borland, Timmins; Chief Wilson, South Porcupine; Chief Merkley, Haileybury; and J. H. Lever, New Liskeard a committee and they reported at the afternoon session as follows:

"We, your committee report that we have gone into the requirements of the Sutherland Memorial Home very thoroughly and have decided that it will take at least another \$700.00 to finish the home in first-class shape for Mrs. Sutherland, and that each department in this Association be asked to raise as much as they can in whatever way they see fit in their respective towns to be forwarded to the secretary of the association as soon as possible."

SUSPENDED FROM OFFICE

Last week Chas. A. Matthews, Deputy Provincial Treasurer, was suspended from office following allegations made in the Legislature by two witnesses before an investigating committee. The witnesses suggested that the Deputy Provincial Treasurer shared in a four-way split of profits made in a deal with the U.F.O. Government over tax-free bonds. Mr. Matthews has made no answer to the charge pending further action by the Government.
