Community Christmas Tree Friday Evening, December 19

Arrangements Now Under Way for Big Community Event for the Children. Committees Appointed by Kiwanis Club. All Children in Timmins to Have Christmas Treat. Band in Attendance.

There is to be a Community Christmas Tree in Timmins on Friday evening, Dec. 19th. All the youngsters of the town are to receive Christmas presents and cheer, and there will be a happy time for everybody. A committee from the Kiwanis Club has undertaken to conduct the event with the co-operation of all other organizations in town and the public generally. The committee from the Kiwanis is subdivided into two committees—a committee of arrangements and a finance committee. The chairman of the Finance Committee is Mr. C. G. Williams and the other members are Messrs. Robt. Dye and T. F. King. Mr. P. Dougall is the chairman of the Arrangements Committee, the other members being Messrs. W. F. B. Cadman, W. Nicholson, H. Jackson and Bert Cooke.

The event will be held on the Public School grounds at 7.00 p.m., and many happy features are being planned for the kiddies. Plans are

under way to have a tent on the grounds for the Timmins Citizens' Band, so that there will be lots of good music. In addition there will be community singing and other features.

The presents to the youngsters will be given out only to those having tickets, so as to prevent duplication. However, all the youngsters in town will have opportunity to get tickets. The tickets will be given out at the schools, and in addition the Kiwanis are going to see that tickets are ready for children that do not receive them at the schools.

Tickets are now on sale to the citizens of the town for the financing of the big community Christmas Tree. Any balance left over after expenses are met will be handed over to the Salvation Army for the distribution of Christmas cheer among the poor of the town.

Everybody should give the fullest possible support and assistance to the Community Christmas Tree.

Mail matter for Great Britain for Christmas delivery must be posted here not later than Dec. 5th.

It is well also during the Christmas season to insure parcels of value going by mail. Postal insurance is inexpensive, parcels for Canada and the United States costing only 3 cents to insure for a value of \$5.00. Six cents will insure up to \$25.00 and so on.

JOHN JONES REPORTS ONE MORE BIG FIND IN DELORO

Brings Out Some 400 lb of Unusually Rich Rock Taken from Near Surface.

Mr. John Jones was in town last week with an array of imposing samples of rich ore taken from his claims in South Deloro. "I've got them all beaten this time," he said. "None of them," he continued, "have ever gotten samples like this from surface and near surface like these are." The samples were strikingly rich specimens of high-grade ore. Free gold showed all over the ore. There were some 400 lb of ore, every piece of which was rich in gold and tellurides to the point of the spectacular.

Mr. Jones said the formation of his property in Deloro was somewhat different to that at other points in the Porcupine, but he said the ore was unusually rich and his new property promised to be a big winner.
