**BIG CROWD DELIGHTED  
WITH SPECIAL CONCERT**

Concert in Aid of Injured Football Players Proves a Success from all Viewpoints

The Goldfields Theatre was well filled Sunday evening last, after the church services, for the special concert given for the benefit of football players injured here this season. The collection was a good one, over \$60.00 being netted for the good cause. The concert itself, which had been arranged by Mr. Jas. Geils, together with other willing workers, including Mr. J. Cowan, was one of outstanding merit. The programme throughout was excellent, and all the various numbers were much appreciated by the audience. Mr. F. J. Wolno made a very capable chairman for the occasion. Mr. R. R. Johnston, L. R. A. M., gave very valuable assistance to the programme by his talented work at the piano. A number of gifted artists had contributed their services for the occasion and the resulting programme was one that greatly pleased all present. Every number on the programme was enjoyed and deserved this mark of appreciation. The Band Quartette — Messrs. Lloyd, Cornthwaite, Wolno and Murphy—gave well-rendered selections that met with much favour. Mr. J. Lloyd, in cornet solo work, maintained the high reputation his gifted playing has won for him. His rendition of "Angus Macdonald," was one of the finest numbers on the excellent programme. Mrs. Barrett's rendition of solo numbers was a delight to all music-lovers, and she was given very sincere and enthusiastic encore. Miss Jean Roberts was another soloist of the evening particularly popular with the audience, her rendition of "Mary of Argyle" winning decided recall. Solos by Messrs. J. T. Heffernan, G. Hale and J. Liddle were also special features of the programme. Mr. Heffernan gave an excellent rendition of "Comfort Ye My People." Mr. Hale's talented singing made special appeal to the music-lovers present. In Mr. Jock Liddle, who made his first appearance on a Goldfields Theatre platform, the audience recognized a decided find in the way of vocal talent. His fine voice was heard to advantage in "The Village Blacksmith," and "Rocked in the Cradle of the Deep." Mr. A. J. Downie added to the attractive variety of the programme by his well-rendered musical monologues that were much appreciated. The guitar selections by Mr. Conn were special favourites, and he was repeatedly encored.

**JUDGE RESERVES DECISION  
IN HANSON CASE AT THE BAY**

In the appeal before Judge Leask from the decision of the North Bay Magistrate in the case of Peter Hanson, charged with being drunk while in charge of a motor car, the Judge last week reserved decision pending investigation of certain technical points brought forward by the counsel for Hanson. Hanson was charged before the Magistrate some weeks ago and acquitted, though three or four members of the police force, as well as other citizens, swore that he was intoxicated. He denied the charge and had several witnesses to support him in this. His acquittal created considerable protest, and the matter was called to the attention of the Attorney-General who ordered an appeal to be made to the Judge, so that the case might be reviewed. At the time in question from which the charge arose, Hanson figured in an automobile accident in which the occupants of the other car were slightly injured. Hanson claims that it was the shock from the accident that made him appear dazed or seemingly intoxicated, but the Chief of Police who took him from the car at the time maintains otherwise. After hearing the evidence, which followed along the same lines as at the original trial, the Judge reserved his decision. The Ministerial Association and the G. W. V. A. at North Bay have been active in having the case brought to public notice, with a view to the facts being made plain. Demands were made at the time the matter was submitted to the Attorney-General for the retirement of the Magistrate and Crown Attorney at North Bay.

**BIG LIQUOR SHIPMENTS  
CONFISCATED THIS WEEK**

160 Gallons of Oh-be-Joyful Will Give No Christmas Cheer Here. Other Police Court Cases.

One of the chief items at Wednesday's police court here was the confiscation of a total of 160 gallons of alcohol coming in here in three differently addressed shipments. Provincial Officer Finger made the seizure on Saturday. The three parties addressed denied knowledge of the shipments, and so confiscation was ordered.

There were five drunks, each fined \$10.00 and costs. Four of them paid but the fifth had not raised the necessary this morning. Unless he gets the \$10.00 and costs he will have to hang up his stocking in jail.

A taxi driver charged with being drunk in charge of a motor car was remanded for a week.

B. Gulka paid \$50.00 and costs for having liquor in a public place. V. Riviera was charged with illegal possession of firearms, and P. Peagueau with carrying firearms without a permit. Both were remanded to next court.

The charge against J. Desjardines, of defamatory libel, as preferred by O. Desjardines, was withdrawn.

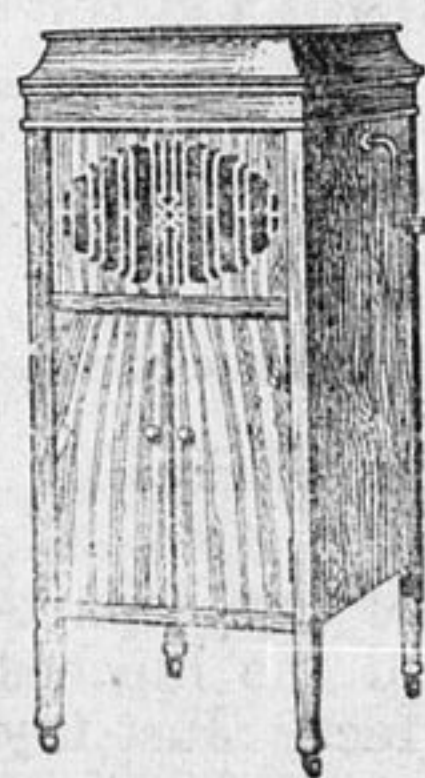
