## Iroquois Falls Juniors Win Junior N.O.H.A. Championship

**Defeat the North Bay Trappers on Their Own Ice, 6 to 2. North Bay Made Poor Showing From Standpoint of Good Sport. Referee Sits on Dirty Tactics. Victory of Falls Greeted With Rousing Cheers Here.**

In the second match in the home and home games for the N.O.H.A. championship Iroquois Falls defeated North Bay on Tuesday evening on North Bay ice by a score of 6 to 2. Iroquois Falls had a big edge on the play, and when the Bay realized this they appeared to try dirty tactics. The fairness and firmness of the referee, Mr. Farlow, of Toronto, kept the game from being a slaughterhouse, but there were spells of rough-house, and on a couple of occasions the spectators crowded onto the ice. A very complete report of the game was received in town through the enterprise and kindness of the Homer L. Gibson Co., whose private wire reported the match play by play. Hockey fans in town greatly appreciated this report. The winning by Iroquois Falls was also very popular here, all cheering for the Falls lads. The North wanted the North to win. When the results were announced at the curling rink, the curlers actually

stopped their games to cheer for the Falls team.

From the running report of the game received over the Homer L. Gibson wire the following report of the match is made:

The period opened with the Trappers on the offensive. The ice was hard and very fast play developed. Hard checking was in order for the first few minutes of the game. Verdon went through all alone and registered the first tally for North Bay, the crowd going wild. The Falls came back with some hard checking and several times the Trappers' net was in danger. Lever was showing up well with his checking. McIntyre went in, and in the dying minutes of the period evened it for the Falls. There was quite a dispute about this goal. The goal umpire did not allow it, but Farlow who was close to the net claimed it was a goal, so it counted. The Eskimos first goal came through Thompson's bad habit of falling in front of his net and sitting on the puck.

The second period developed into a hectic session. The Trappers took the offensive, and redoubled their efforts when Lever went to the box for tripping Barclay. Kerr proved himself unbeatable, six hard shots being rained in on him in quick succession. The second Falls' tally came when McIntyre and McBride went through the whole North Bay team and found the net behind Thompson. Kilby went to the box for hooking. Verdon spoiled a fine combination rush of the Eskimo forwards, and sent one in on Kerr, the goalie losing his stick in his effort to clear. McLeod went to the box, to be joined right after by Barclay. McCabe drew five minutes when he bodied McIntyre into the boards. The play was roughening up at this time. McLeod took a trip for tripping, McBride joining him for the same offence. Hayman and Kilby mixed it and were chased by the referee. A fight started in the penalty box, the referee stopping the game while he investigated. When the smoke of battle had cleared and play was resumed there was only one Falls player and three Trappers on the ice. The penalties continued coming thick and fast, McBride, Hayman, both took a trip. McIntyre made it three for the Eskimos when he went through in a pretty piece of stick handling and scored. Right after Fillman went in and made it four for the Falls. The play during the whole of the second period was rough. Referee Farlow had the game well in hand except when the fight started in the penalty box. Fillman and Kerr were the only Falls players on the ice against three Bay forwards, but Kerr was unbeatable.

The third opened with the Eskimos still pressing hard. Lever was hurt, and replaced by Kitson. Kerr made a spectacular save from McCabe's shot. Fillman went to the box for tripping Palangio. Verdon went off right after for butt-ending. McLeod went in and after three tries finally succeeded in landing the puck in the net behind Thompson. Iroquois Falls 5. Verdon and Lever took a trip when they mixed it, and shortly after McLeod drew the ire of the referee when he cross-checked Barclay. Fillman and McLeod made it six for the Falls when they went through in pretty combination and McLeod scored. Kerr, the unbeatable goalie, and Barclay both went to the box for fighting. Barclay charged the Falls citadel-minder and Kerr swung at him. McBride took his place, but his team mates saw he hadn't much to do. Kerr returned. The spectators invaded the rink, and a general mix-up seemed likely. The argument was over the Barclay-Kerr penalty. The police again took charge when Palangio and the Trappers coach got into a fight. The Trappers seemed to be taking their defeat in a poor manner. The whole third period was mostly a free-for-all. The Trappers did not shed any added lustre on their name, the continued scoring of the Eskimos seemed to get them angrier with each goal. The Falls won on their merits.

## DATES, ENTRIES, WINNERS IN PREVIOUS DOG RACES

Twelfth Annual Dog Race to be Held at Timmins on Wednesday, March 16th.

So far as known the Porcupine Dog Race is the oldest event of its kind to be run each year, without skipping a year. The race at the Pas, Manitoba, lost its leadership in this line by dropping the event for a year or two during the war.

The Porcupine Dog Race has been run each year for eleven successive years. This is the twelfth race,—to be held on Wednesday, March 16th, 1927.

"Dog Race is pretty late this year," is a comment frequently heard. The answer is that it is earlier than in some past years. For instance, in 1921, it was held on March 20th. The latest was 1916—the first year—when it was held on March 25th, after being postponed a couple of times.

It will be of interest to note the dates, winners, entries, etc., for the several races to date:

March 25th, 1916—Joe Brisson, winner; 1 hour, 32 minutes, 37 secs. Second, L. S. Newton, 1 hour, 34 minutes, 51 secs. 9 entries.

March 10th, 1917—Geo. Cousineau, 1 hour, 18 minutes, 35 secs. Second, O. Laroque, 1 hour, 27 minutes,—10 entries.

March 16th, 1918—W. Martin, 1 hour, 33 minutes, 23 secs. Second, F. M. Wallingford, 1 hour, 47 minutes,—8 entries.

February 22nd, 1919—W. Martin, 1 hr. 33 min. 23 secs. Second, Jean Pare, 1 hr. 35 min.—7 entries.

March 20th, 1920—W. Martin, 1 hr. 28 min. 19 sec. Second, F. M. Wallingford, 1 hr. 41 min. 2 sec.—8 entries.

March 19th, 1921—W. Martin, 1 hr. 26 min. 13 sec. Second, A. Belek, 1 hr. 35 min. Third, D. Goudis, 1 hr. 36 min.—11 entries.

March 4th, 1922—W. Martin, 1 hr. 33 min. 50 sec. Second, Walker, 1 hr. 35 min. 56 sec. Third, C. E. Myers, 1 hr. 45 min. 56 sec.—12 entries. Of this dozen entries, three were women drivers namely, Mrs. H. Darling, Mrs. Murley, and Miss M. Martin.

March 10th, 1923—W. Martin, 1 hr. 14 min. 45 sec. Second, John Landers, 1 hr. 21 min. 20 sec. Third Victor Bissonette, 1 hr. 28 min. 25 sec. Fourth, Wm. LeClair, 1 hr. 28 min. 50 sec.—15 entries—the largest entry list yet.

March 8th, 1924—1st. W. Martin, 1 hr. 18 min. 55 sec. Second, St. Pierre, 1 hr. 19 min. 35 sec. Third, McLean (Cochrane), 1 hr. 20 min. 55 sec. Fourth, Bridges, 1 hr. 24 min. 5 sec. Fifth, McMillan, 1 hr. 29 min. 10 sec. There were twelve entries in this race, but only nine of these turned up to make the actual start.—9 entries.

March 6th, 1925—First, Wilbord Poirier, 1 hr. 18 minutes, 5 seconds; 2nd, W. Martin, 1 hr. 22 minutes, 6 seconds; 3rd, M. MacMillan, 1 hr. 27 minutes, 26 seconds.—11 entries.

March 12th, 1926—1st, S. Pancoff, 1 hour, 8 minutes, 16 seconds; 2nd, W. Poirier, 1 hour, 9 minutes, 40 sec.; 3rd, M. McMillan, 1 hour, 11 min., 3 seconds.—9 entries.

Last year a new record was made for the present course of the speed race. The previous record was made by W. Martin, 1 hour, 14 minutes and 45 seconds. For the old course, Geo. Cousineau's record of 1 hour, 18 minutes and 35 seconds.

The Freight Race was inaugurated in 1922 and has attained great popularity. In 1922 the winner was Mr. H. Darling. Mr. J. Clifford's team won the 1923 event. The 1924 winner was Mr. L. Reid, and Mr. Philios Bouvereau was the 1925 winner. Last year's freight race was won by Fountain, of Ansonville, his time being 24 minutes, 7 seconds. Boudreau was nine seconds slower for second place, and Bissonette a close third.

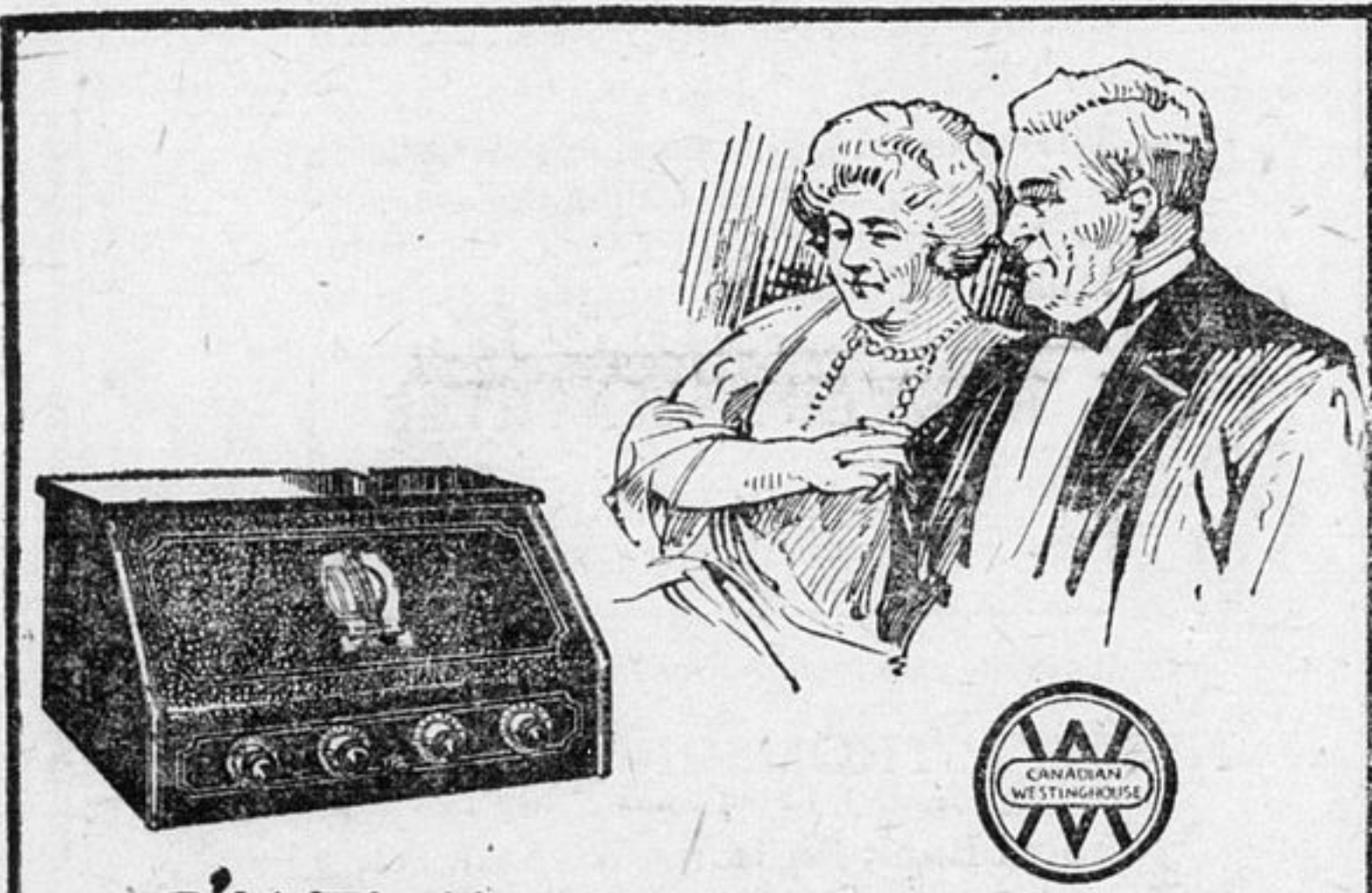
