"GRAVEL AND SAND"—AND PLACER

At one of the recent meetings of the Canadian Legion endorsement was given to the proposal that a community building should be erected in Timmins. It is to be hoped that other organizations will join with the Legion in advocating the proposal for a community building. The need here has been apparent for years. The cost has been the principal reason why the proposal has not been carried out before this, but it is easy to see that the returns, direct or indirect, would outbalance any expenditure involved. It would be an investment in better citizenship and a better town.

A news item in the daily newspapers recently gave the information that Russian explorers in Tibet had found an ape that they considered so intelligent that the animal was made a member of the party. The attention of the Society for the Prevention of Cruelty to Animals is respectfully called to this item.

From statements made in the Ontario Legislature last week it would appear that Hon. E. C. Drury, former premier of Ontario, has threatened to punch Hon. Mr. Lyons' nose the first time the said Mr. Drury meets the said nose on the street. Hon. Mr. Lyons says that he is unafraid, and so the meeting of the two is awaited with interest. Members from the North are no doubt attempting to arrange a similar bout between Messrs. Nickle and Raney, without especial choice as to which wins. They would be well-matched for such a contest, though there is a general feeling that Hon. Mr. Raney is pretty small.

The Advance has given considerable space and prominence to the suggestion of Mr. H. A. Preston that a belt line of roads be completed in this North Land. The Advance has no other excuse to offer for its advocacy of the proposal than the belief that it would be of great advantage to the North. Only a small amount of roadway needs to be constructed to complete the belt line and the cost will be trivial compared to the advantage. The completion of the roads in question would mean the opening up of the country south of Timmins, a particularly promising area, rich in minerals, timber and fish and game. It would mean also a great impetus to the tourist traffic expected in this North Land when the highway is completed from North Bay to Cochrane, Iroquois Falls and Timmins. The belt line of roads would mean that the tourists could travel to the North by one route and return by another. This would mean an attractive feature, appealing to tourists considering the idea of visiting the North and the tourists who actually visited here. A belt line of roads would double the attraction of the North Land so far as tourist traffic is concerned, and it would also give the tourist traffic almost a double value to the country and its development. Extended reference to the belt line plan has been made by The Northern News, of Cobalt, and The Haileyburian. It appears to The Advance that every newspaper in this section of the North should take the question up with earnestness and enthusiasm. Such a belt line of roads would not only advantage towns like North Bay, Cobalt, Haileybury, New Liskeard, Iroquois Falls, Cochrane, Kapuskasing, Timmins and Sudbury, but it would also mean much in adding to the progress of development of the whole country. Because of lack of direct communication with the larger centres, the area to the south of Timmins has not made the progress in development that its wealth of resource would warrant. It would be greatly assisted by the proposed belt line of roads. Mr. Preston, who knows the area with the intimacy of the old-timer, describes it as a sportsman's paradise, a miner's Klondyke, a treasury of noble scenery for the tourist. The cost of linking up this promising territory with the larger centres of the North, and doubly linking up the whole North with the South, would require a very small expenditure. Only three small strips of road require construction to make the belt line. Direct communication with Sudbury, as well as North Bay, would be achieved by the belt line of roads. The plan appears a particularly worthy one and deserving the thought and attention of the press, the boards of trade, the parliamentary representatives and the people of this North.

It is to be hoped that announcement of a new post office for Timmins is not being reserved until three weeks from Friday.

In the discussion that has arisen from the recent resolution introduced at a meeting of the Cobalt town council to provide for the payment of the councillors for their services, one point has been overstressed and another overlooked. The point overstressed has been the one based on the idea that the labourer is worthy of his hire. The point overlooked is the tendency for unsuitable men to be attracted the minute there is any money in the work. The cost of properly paying for municipal service is really prohibitive. Good citizens have to contribute their services free or for only a fraction of the cost or worth. The small amount that can be paid by municipalities under present conditions does not recompense men for the time and talent given to public service. At the same time there are always those to whom the small fee appears to be easy money. It attracts this class to public service, and this is no gain for the municipality. In more than one municipality where payment has been arranged for municipal services, it has been the experience that there has been a regular rush of the type of men who never attempted to give any service before, and who apparently believe a little money is a whole lot. Municipalities can, however, pay for the loyal service they receive from public-spirited citizens by treating those citizens with a fair measure of goodwill and appreciation.

The murderer of Inspector Constable at Cochrane last October is still unpunished. This is one of the cases where the phrase has a particular application that "something should be done about it."

Very pleasing response has been made to the first call for payment of 1926 taxes, yet much of the first instalment and most of the second instalment still remain to be paid. The town is paying interest on borrowed money until the 1926 taxes are paid, and this procedure of course is a costly one. All citizens who can pay should do so at once, paying all the 1926 taxes or a part, as may be possible. It means a decided saving to the town. Of course, there are some who find it impossible to meet the obligation. If those who can pay, do pay, the burden of carrying those unable to pay will be lighter. All 1926 taxes should have been paid last year, if normal conditions had prevailed. There was a municipal muddle through the selection of unsuitable men for some municipal offices, and now all that can be done to right the undesirable conditions resulting is for each and every citizen to do the best possible to make the consequences as light as possible.

The North Land highway will be completed this year, and tourists from the South may be assured that this North Land will amply repay them for a visit. Apart from what they will see of interest and importance in the line

of mining, lumbering, agricultural and paper making industries, the scenery alone is well worth coming five hundred miles to see. Many of the people living here fail to respond to the beauties of the land, perhaps because the beauties are free and common. The majesty of wide spaces is often forgotten in the nipping cold or the inconveniences that sometimes accompany nature in a more or less artificial world. But poets yet will sing of the beauties of the great north—the forests on sentinel duty guarding the wealth of this land; the glistening snow of winter and the green and colours of the warmer days. And all the year, the striking beauty of the Northern Lights will impress all artists and all poets, for, perhaps, nowhere else are the Northern Lights so full of interest and of beauty as in this North Land.
