QUEBEC ALSO SENDING FAKE BROKERS TO JAIL

RECORD OUTPUT MADE BY THE LAKE SHORE MINE

Lake Shore Mines had a record production for the three-month period ending December 31st last, the second quarter of the fiscal year of the company. The figures just released show that the output exceeded by \$224,000 the previous record for a similar period, and they were more than \$270,000 above the production for the previous quarter, ending September 30, 1927. The production for the quarter was \$1,035,000, the official figures issued by the company indicate. The grade of ore increased by \$5.35 per ton, and reached an average of \$17.83 for recovery. The tonnage milled, while down by 35 tons daily, averaged 645 tons every 24 hours. Anticipations are that, by Spring, the mill will be operating on a 1,000-ton-a-day basis, with the mine developing to the 1600-foot level, and through two shafts.

Out of ten indicators of conditions throughout Canada reported by the Canadian Government Dominion Bureau of Statistics, nine showed that Canadian trade and manufacturing were on a higher level at the end of 1927 than they were at the end of 1926.

Capper's Weekly: One reason shoes cost so much more than they used to is that about a thousand styles are made and new ones are constantly being created. It is nonsense to say that a customer must have that many styles to select from, but highly expensive nonsense for which he pays and will continue to pay until common sense restricts styles in footwear to a reasonable number in quality and shape. As it is now, shoe dealers have to carry too large and too varied a stock and some of the styles do not sell. That means a loss, ultimately paid for by the consumer.

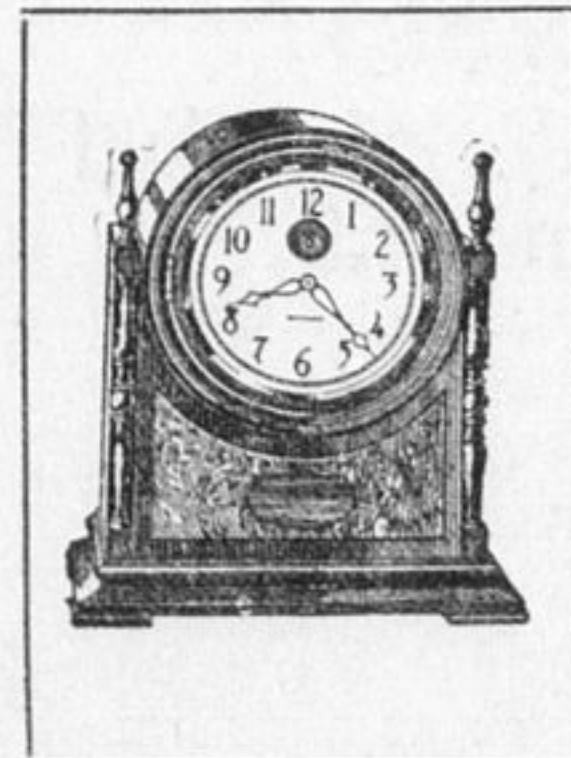

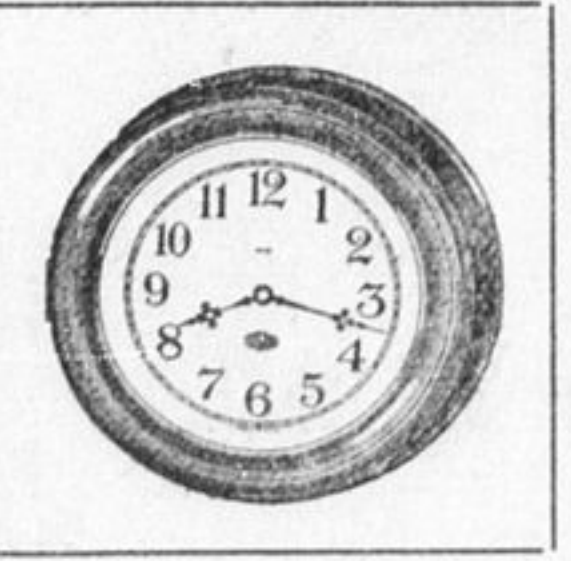
