

DRUG STORES NOT TO SELL GENERAL GOODS AFTER HOURS

 case for another three months. Then they had felt they had done as much as they could and they approached council to help with the case. They

understood that council had served in this, and had notified the hospital that the Kiwanis would not be longer responsible. They had acknowledged of this from the hospital. The hospital, however, had failed to notify the town in the matter. The boy was still at Toronto. The amount due the hospital to Aug. 17th, is \$722.05. While the Kiwanis felt they were not liable for any of this, they felt some measure

of moral responsibility, and so were ready to pay up to half the bill if the council would pay the other half. As the hospital was really responsible for the misunderstanding, through failing to notify the town after accepting the Kiwanis withdrawal, it was felt that the hospital should reduce the bill. Mr. Rinn pointed out that the responsibility for the present situation could fairly be placed on the hospital au-

thorities. He felt the Kiwanis Club would not legally responsible, but they would like to see the matter settled and the boy brought home, as he was not making progress as expected. In answer to the suggestion that the Kiwanis had attempted more than they could carry out, Mr. Rinn pointed out that this was not the case, but that actually the Kiwanis had done about double what they agreed to do in this case. The Kiwanis thought the council might take up the matter with the Hospital for Sick Children and have the matter adjusted.

Council felt it had no responsibility whatever in the matter, having not been notified as required by law. Mayor Drew thought the Kiwanis should take up the question with the hospital and make the best bargain possible in view of the hospital's oversight. In case the Kiwanis did this, the council agreed to help out in the payment of the bill, the boy to be brought back at once.

M. Riard asked council for rebates on water rates where water was not used. The committee will look into these and grant them if circumstances warrant. Mr. Riard's request for a refund of dog tax on a dog that was killed could not be entertained.

A lady appeared before the council to protest against a charge of \$1.00 per day that she understood the bailiff would charge her until her back taxes were paid. She was paying the back taxes at the rate of \$50.00 every two weeks, but could not pay any \$1.00 a day for costs. Council explained that as a seizure had not been made of the property, the chances were that she had misunderstood the bailiff, as he had not collected the \$1.00 a day in cases where he had not made a seizure and was in daily charge of the property. The lady was assured that the matter would be looked into.

A resolution was passed for the taking over of four lots on which taxes were due but not easily collectable, the original owner of the lots which had reverted to him, agreeing to deed them to the town. Two of these lots had excellent gravel on them, and the two others had apparently also good gravel. The town needed the gravel and the two lots alone were worth more than the taxes on all four.

Monday, August 19th, was named as civic holiday for Timmins. Mayor Drew commented that a Wednesday civic holiday was not a good idea, meaning only a half holiday.

Reference was made by the mayor to the request of one of the town jewelers to be allowed to keep his store open at nights, as the drug stores were selling jewelry during the early closing hours and this was unfair. After some discussion council came to the conclusion that the only way to remedy any unfairness was to make all live up to the early closing by-law. It would not do to allow the jewelers to keep open as this would eventually mean that all the stores would be equally entitled to keep open. The drug stores handled other lines such as hardware lines. The by-law specified that no store could sell hardware, jewelry, sporting goods, etc., during the closed hours, whether other lines were carried or not. This applied to drug stores. On motion the clerk was instructed to write the drug stores in town advising them that they must adhere to the town by-laws respecting the sale of jewelry, hardware, sporting goods, etc. It was understood that if the drug stores do not comply that the police will proceed to strictly enforce the law in regard to the sale of goods after the regular hours observed by other stores.

A resolution was passed naming the council of the municipality as the local pensions board, with the mayor as chairman, and I. E. Dunn as secretary. Reference was made by the mayor to the visit here on Wednesday of Rabbi Isserman, of Toronto. Any of the council who could meet him were asked to do so.
