In any event the fire ignited some hay in a loft over the stable in the fire hall and the blaze spread to the roof. The firemen were able to extinguish the blaze before any serious loss was sustained. An alarm was turned in, but the firemen had the blaze under control in short order Some bales of hay and bags of oats were soaked with water as a result of the fight against the fire, this being

the chief damage resulting. Speaking of fires at fire halls, at banquet some years ago Chief Borland told of Canadian fire halls that had actually been destroyed by fire. As the chief pointed out if a fire actually got any sort of a start in a fire hall it was harder to fight it there than in other places on account of the chance of the fire-fighting equipment being damaged by the fire or at being impossible to reach it on account of the fire and smoke: Fire halls are not exempt from fires any more than police stations are exempt from thefts and other crimes. The following is the fifth of the series of questions and answers in reference to football:-50. When is a player offside?

Answer:-It is not an offence for player to simply be in an offside position, but only when in that position the ball has been passed towards him or he attempts to play the ball, or in any way obstruct an opponent, or caus

player be offside? Answer:-A player can never be offside at a corner kick, goal kick, place kick, throw-in when the ball was last played by an opponent, or when the ball was passed back to him, or if he had two opponents between him and their own goal-line when the ball was passed to him. 54. How should the player throw in

the ball from touch? Answer:-The throw-in shall be taken under the following conditions:-A player of the oppsite side to that which played it out shall throw it in from the point on the touch-line where it left the field of play. The player throwing the ball must stand with both feet on the ground outside the touch-line facing the field of play, and shall throw the ball in over his head with both hands in any direction, and it shall be in play when thrown in. A goal shall not be scored from a thrown-in, and the thrower shall not again play until the ball has been played by another

55. Where shall the ball be kicked from at the taking of a corner kick? Answer:-When the ball is played side whose goal line it is, a player of the opposite side shall kick . it from within one yard of the nearest corner flag-staff.

56. Is it an offence for a player who takes a throw-in to again play the ball before any other player has done so? Answer:-A free kick from which a goal cannot be scored direct may be awarded against a player who plays either ball or man after throwing it in from touch before any other player

58. What is the length of the interval that players have a right to at half-time? Answer:-Five minutes.

59. What method should a referee adopt to ensure that he plays the exact time?

Answer:-Referees should always compare their time with both linesmen before the start of the game and at the re-start after the interval.

60. After a stoppage of a game through accident how and where should the game be re-started? In the event of any temporary sus-

pension of play from any cause, the ball not having gone into touch or behind the goal line, the referee shall drop the ball where it was when play was suspended, and it shall be in play when it has touched the ground. I the ball goes into touch or behind the goal-line before it is played by a player, the referee shall again drop it.

61. What award would be made if a defending player struck the ball with his hand inside the penalty area when dropped by the referee before it reached the ground?

Answer:-A free kick must be awarded from which a goal cannot be scored

62. If a player uses foul language towards a referee, what does the law term it, and what are the powers of the referee in that case?

Answer:—A referee has the power to order a player to the pavilion without any previous caution if he uses violent or bad language towards him; wilfully obstructs the progress of the game; assaults an opponent, on wilfully injures an opponent. Swearing at a referee is violent conduct within the means of the laws.

#### INQUEST TO BE HELD INTO DEATH OF ELOI MELOCHE

leath of Eloi Meloche who was one of the two killed in the shooting affray at Kirkland Lake some weeks ago. As noted in The Advance two weeks ago there was question raised as to whether Meloche shot himself after shooting his common law wife. The opinion after the tragedy first came to light seemed to be that Meloche shot the woman and then turned the gun on himself. The fact that there were few signs of powder burns on Meloche and the number of shots supposed to be fired, together with those that could be accounted for, raised some question as t the possibility that the shot that killed Meloche might have come from another gun than his own. As soon as this question was raised the police made very thorough investigation in the matter to remove all doubts and lay the truth bare. To satisfy the public mind in the matter an inquest is to be held into the death of Meloche. The previous inquest covered the death of Meloche's common law wife. In connection with the question The Northern News of Kirkland Lake says:-"Investigation to clear away any doubt that Eloi Meloche came to his death on Dominion Day, by any other hand but his own, are being carried on by the police authorities. Groulx, who was shot as he left the house where Miss Pelletier was murdered, is now out of the hospital and is able to more clearly recall events as they happened that fateful morning. 


