Engineers—p, Sullivan; c, Fell; 1b, Crozier, (B. Doran); 2b, Michaelson; 3b, H. Doran; ss, Cook; lf, McMurray; cf, Richmond; rf, Murray. In the first innings Cook, Doran and Murray made the home plate for the Engineers and Clark, Brooks, McManus, Johns and Ostrowsky registered for the Mine, McManus scoring Johns on a two-baser. Michaelson for the Engineers batted a home-run scoring Cook and Doran ahead of him. No more runs were tallied by either team until the first part of the fourth when H. Doran came home as Murray hit a two-baser to be followed by Michaelson Murray and Sullivan all on the last named's home-run. In the second part of this session the Mine showed they could make it ten runs too, Burke, Clark, Brooks, Johns and Wagner doing the tricks, Brooks' two-baser sending Burke in, Johns two-base hit then scoring Clarke and Brooks and a home-run by Wagner putting on the finish before McManus, Ostrowsky and Pollard went down three in a row. No scoring was done in the fifth. Then in the sixth something happened. It looked as though the Miners were training those Engineers to be homing pigeons, the way they made every conceivable error to give them practice on rounding off that diamond. Richmond hit out, then no less than fifteen runs were scored by the fifteen batters who went up. Mr. Ed. Ahr, of the Algoma Air Transport service here, was called on last week to help find a man reported lost in Carcassien and was ready in his usual prompt way. It was later learned

we believe, that the man was not so seriously lost; as had been first supposed.

In the police court on Tuesday one case took up most of the morning. The others were briefly dealt with. A man found driving a motor vehicle who had neglected to carry his permit was fined five dollars and costs. A young girl who did not look to be out of her teens was called to answer a charge of having liquor without a proper permit and asked to have the case adjourned for two weeks. The lengthy case was a sort of sing-song "Who broke Laroche's window?" to a tune that brought memories of "Who killed Cook-Robin?" The window was alleged to have been broken on the night of August 20th. Two young men leading guilty last week to being drunk were involved in it. In fact the whole thing arose out of too much drinking. Some fifteen witnesses were brought twenty miles over that broken window. Some had been called on the same case last week and another is still to be called next week as it has not been decided yet who broke Laroche's window. The first witness with a flow of words told of being there but on the inside so did not see on the outside who broke Laroche's window. Witness number two was deaf but had heard a smash. He didn't see who broke the window. Witness number three simply said he didn't know who broke the window. Next came a boy of nine years. He with the little boy across the street saw who broke the window. The man accused had a stick in his hand and he broke the window. Number five didn't know anything about it at all. Number six saw no plunk but saw accused after the glass was broken. Number seven was upstairs with her mother and didn't see who broke the window. Number eight heard accused tell another fellow to break in the door but didn't see who broke the window. She threw a flat iron from the upstairs window that is supposed to have broken one man's head a bit. She also threw a chair that allegedly hit another fellow but he didn't know about it. She saw the first witness called with a plunk but didn't see who broke the window. She also told of hearing swearing. Witness number nine heard glass smash when she was upstairs and swearing with the smashing but didn't see the

window broken. Number eleven who was plaintiff did not see the window broken. Number twelve for the defence said he saw a man not in court room put his fist through the window. Number thirteen's evidence was not allowed as it was only hearsay. Number fourteen bandaged a broken head but knew nothing about the broken window. Number fifteen was called at the request of the magistrate. He was the father of the man accused said had broken the window. He said he did not pay for the broken window as stated by some but had told his son he had to scare the son he would keep out of trouble. And still it is not settled "who broke Laroche's window," the evidence of the "screed" son remaining yet to be heard. To another charge of using obscene or profane language over the phone accused pleaded guilty and was fined twenty-five dollars and costs.

There will be a box lacrosse game in the arena, South Porcupine, on Friday night of this week between Timmins and South Porcupine. This will be the sixth of the scheduled series.

Dome Football Club have now the right to meet Lake Shore Mine of Kirkland Lake in the chase after the Byrne Charity Cup. They won from the McIntyre on their own grounds last Saturday 5-1 and in the return game at Timmins on Tuesday 4-2 giving them the round by 9-3. The game of the season will be a sudden death played next Saturday at Timmins grounds between McIntyre and Dome teams. This is the first of the Ontario Cup series, the winner of this game meeting the winner of the Falconbridge-Kirkland Lake game played the same day at Kirkland Lake. The finals for Northern Ontario will be commenced the following week.

W. Barron, of Schumacher, was referee for the game at the Dome last Saturday. The teams—McIntyre—goal, Vennard; backs, Hampton, Place; half-backs, Nee, McMullen, Bennet; forwards, Chalmers, C. Dawson, Chevalier, J. Dawson, and Gray. Dome—

goal, Baxter; backs, Pryor and McGuire; half-backs, Munro, Crawford, Whyte; forwards, Tennant, T. Blair, W. White, McManus, Rogers; spares, Chambers for White, Foster, Cook. The work of the two goaltenders was sensational, Vennard having a much harassed game to play and the goals secured from him being the type that couldn't be stopped. The one that got by Baxter was from a penalty kick off the boot of Hampton. In the first half Vennard made nine stops, Baxter eleven. In the last Vennard was tested fourteen times to Baxter's seven. Dome pressed from the kick-off, White getting the first drive on the net, Pryor's strenuous checking of Gray aggravated McIntyre fans. A Tennant to White play was hoisted so far into the bush a search party had to hunt the leather. Place, a new man on McIntyre line, did some good checking and placed his kicks to good advantage. W. White fooled both Place and Hampton to get a line right on the net and made Dome's first tally. C. Dawson took the leather from both J. Whyte and McManus in a pretty piece of work. A Bennet to Gray to Chalmers threat was ward off by McGuire. Hampton made a clever save from White in a race toward Vennard. Chalmers got another nice shot on Baxter picking up a pass from Chevalier. McMullen next tried the Dome citadel in vain. The McIntyre were forcing the play but relief came when Pryor booted the ball back to the other end. A kick from Place brought it back and again Baxter and the rear-guard of the Dome were busy men. A McMullen to Chevalier play registered nil. Gray to C. Dawson was spotted by Pryor. J. Dawson was outlucked when his shot hit the cross-bar. Gray got to the scoring area but couldn't make it. J. Dawson again tried Baxter and in quick succession the Scotch lad had to run out to stop Chevalier. McIntyre had the edge in this half but were unfortunate around the net. The next period was very much Dome. McManus quickly raised the score to two. A penalty kick got one for the Maes. In the next rush on Vennard, Chambers registered a third. Vennard was staging some work that brought a glad hand from all fans. When play was transferred Baxter fisted over Nee's shot and C. Dawson's was skied. Back again Cook fooled Bennet to pass to Chambers but the aim was poor. A corner for Tennant was given. The lad made a curving kick on goal that just hit under the corner of the crossbar at the far side and tallied. That is the second time this season Tennant has accomplished the unusual feat of scoring directly from his own corner kick. Later the same player was sandwiched in a check and then got a bump that forced him to retire for the remainder of the game. Vennard made a nifty save off Rogers. McManus to Chambers gave Dome their fifth. The final whistle blew on a 5-1 score being a rather formidable handicap for the Maes' return game.

Among officers at the reunion were Major W. W. Fraser, who was second in command, and Lieut. R. B. Young, Toronto; Major W. W. Ferguson and Lieut. J. Bourke, North Bay, and Capt. T. A. Ellis, London. At the banquet Saturday night plans were launched for formation of a permanent association.

The 228th was recruited in Northern Ontario in 1916 and served in France in 1917 and 1918 with the sixth Canadian railway troops.

The number gathering last week at North Bay for the reunion was not as large as had been expected, but a notable start was made and a much larger crowd is hoped for at the next reunion. The event itself was a remarkably successful and pleasant event.

Saturday afternoon there was a parade through the North Bay streets, headed by the North Bay Pipe Band and the Citizens' Band, the march ending at Memorial Park, where a service was held for the departed comrades, Rev. P. C. Reed, minister of the North Bay Baptist church, conducting the services, and the soldiers placing a wreath on the cenotaph. The address by Rev. Mr. Reed was an able and eloquent one. A large and representative crowd of citizens also took part in the service. Other speakers at the service were—D. W. Reeves, president of the North Bay branch of the Canadian Legion; Rev. J. M. McCurlie; Rev. J. L. Kennedy; Mayor Richardson; Chairman Geo. W. Lee, of the T. & N. O. Ry.; Rev. Geo. S. Easton, minister of St. Andrew's United Church.

Following the dedication address the "Last Post" was sounded by Bugler Albert G. Smith after which Comrade W. Forman reverently placed a wreath against the plaque to the unknown soldier. This was followed by the playing of "Flowers of the Forest," by a member of the Pipe Band. Reveille was sounded by Bugler Smith and the audiences joined in singing "Onward Christian Soldiers." The service was concluded with Rev. P. C. Reed, minister of the First Baptist Church, pronouncing benediction.

The service was very impressive throughout and was a notable event throughout.

At the banquet in the evening, which completed the day's card, a delightful programme was carried out, including addresses by Mayor J. W. Richardson, George W. Lee, D. W. Reeves, Col. W. H. Milne, Judge J. M. McNamara, and toasts to the battalion and ladies' auxiliary by former officers and Judge McNamara.

Luontti's orchestra. Ernie Lavery, as "Dr. Augustus Piffle," further entertained the gathering with his comical descriptions of products of his "inventive genius." Following the toast to the King a one minute silence was observed.

At the close of the banquet, T. A. Willis, lead the gathering in giving a hearty hand of applause to show appreciation to H. J. Reynolds and Leonard Dreaun, who had worked so diligently to make the re-union a success. Other guests who occupied places at the head table, but who weren't called on to address the gathering, included Rev. P. C. Reed, minister of the North Bay Baptist church, and Rev. G. S. Easton, minister of St. Andrew's United Church. It was unanimously decided to make the re-union an annual affair.

All former members present were instructed to send in as many names as possible of other ex-members of the outfit to Leonard Dreaun, secretary, as soon as they could secure them, in order that in years to come the re-unions would be attended by greater numbers than this year. Due to the fact that there was some division of opinion as to what dates the events should be held on in future, those present were requested to send in their suggested dates after returning from this one.
