## JUDGMENT RESERVED IN AUTOMOBILE DAMAGE CASE

Judgment was reserved by His Honour, Judge H. D. Leask in a civil action of Dr. W. J. Linghorne, New Liskeard, vs. F. Falzetta, Sudbury, arising out of a motor accident on the Ferguson highway in the summer of 1931, and heard Wednesday last week at North Bay in district court. Linghorne, the plaintiff, sued for \$642.30 damages to his car, and the defendant counter claimed for \$928.80. The case had been referred to Judge Leask by the Supreme Court. The hearing took up the entire day, lasting until seven o'clock and 10 witnesses were heard. McDonald and Tilley, North Bay, acted for Dr. Linghorne, and O'Connor and Facer, Sudbury, for the defendant. The latter's car had been driven by John Sokolsky.

## To Appreciate Canada Try Living in Russia

"If you want to appreciate Canada just spend two years in Russia," J. A. McLaughlin, British Columbia mining engineer told the Vancouver Board of Trade in a luncheon address. McLaughlin recently returned after spending a year and a half developing copper properties for the Soviet government.

Soviet and the five year plan, he declares, have been terrific failures. If the Russian people were free to come to America not ten per cent. of them would stay in Russia, he asserts. Mr. McLaughlin said there is probably as big a percentage of Communists per population in Vancouver as in the total of Russia. Three million Communists run the country over there with a population of 160 million.

"Their slogan," he said, "is to do in ten years what America has done in 100 years. If they reverse those figures they may come somewhere near it. The copper mine where I was sent was scheduled under the five year plan to produce 10,000 tons in the first year. The figure was later extended to 14,000. We produced 600. In Moscow the streets are crowded, so are the street cars. The diet consists of black bread, cabbage, potatoes, a little meat, little sugar, butter for a month that would be enough for one meal. They are shipping out all that is saleable.

"They wouldn't believe me," he concluded, "when I showed them the menu that is being given to men in B.C. unemployed camps. They doubted that anyone in the world was fed that well who didn't work."

## Regular Meeting of the Tisdale Council

Relief Cases as Usual Feature the Session. Refund Made by Department of Fine Imposed on Schumacher Young Man.

South Porcupine, Ont., Dec. 14th, 1932. Special to The Advance.

Tisdale Township council met in their chambers on Monday evening with the reeve and all the councillors present. There were many supplicants present who were heard after the reading of the minutes of last meeting.

The first was a Frenchman from a farm in North Tisdale. At this home there are nine dependents on the charity of the council for enough to eat. These who are able are cutting wood but it is green and not very saleable this winter. These people think they can get through on less than \$1.00 each allowance per week and were allowed \$8.00 per week at the grocery to be renewed from week to week. Next came a Finn who will be in Canada two years in April and has been out of work practically all the time. He claimed he was on the relief here a year ago but had been in Red Lake since. The clerk was instructed to check up on his registration, etc., before any relief would be allowed.

The next man, a Bulgarian, wanted his taxes cancelled as he could not pay them but was told to try to pay five dollars on them whenever he could get it. Then came a Polish man who had worked at the Dome in 1927 until the mill burned. He claimed friends had helped him for the past two years but that they were either away or needing help themselves now. It was considered he would have to be fed. Another fellow countryman, who sleeps at a friend's on Golden avenue, had only had odd jobs for a long time and could not get that now. He had been to Sudbury and Rouyn looking for work but could not get it. The reeve remarked when the facts of these men were sifted down, "I guess they're ours. Somebody has to feed them. The railway and steamship companies made their profit bringing them in." Councillor Hawkins remarked, "No one else seems to be claiming them anyway."

"Dad," a well-known figure around town, wanted more clothes but was told if the ones he had were brushed up they would do very well. R. Campsall, a wood merchant of town, was present bringing five likely looking men with him. He had work for six months of the winter but these five had no boots, socks or mitts fit to go to the bush and the stores would not advance the clothes to be held out of their pay. The men seemed very anxious to go under the conditions guaranteed and the council arranged for the price of warm clothing to be taken off their first pay. The sixth man had clothes enough.

An old couple, who are property owners here, but have had many drawbacks, were present wanting their taxes cancelled, but the reeve said they would just be let stand against the property and perhaps next year they might be in the wealthy class and could pay them. The old lady was spokesman and said, "If I am, I won't forget you folks. It's all right when I know all you folks but I don't know that other bunch that are coming in. There's no telling what they might take it into their heads to do." This created a general smile especially as Councillor Hawkins is one of the "elect" in "that other bunch." However, the council assured her that the other bunch might be just as good as this one and though still looking dubious she left wishing them all a merry Christmas.

Councillor Laforest's bill for a scrap made at his shop was fourteen dollars instead of the expected fifty that it was thought it would cost when it had been priced elsewhere.

There was correspondence and telegrams re the moving of machinery from the property of a mining company near here as the township has an injunction against this property which the mine's representative in Hamilton acknowledged was still good but wanted this machinery released. This township refuses to do until better settlement financially can be reached. It is deemed that there is already one thousand dollars which was paid on material from there awhile ago, to which the township feel they had prior right, but which was withheld from them. The matter is being placed in the hands of their solicitor and the clerk was commended for his promptness in staying the removal of the machinery.

There was a letter from the Attorney-General's department refunding part of a \$100.00 fine levied against a newly-married man in Schumacher last summer as evidence showed he had acted in good faith in making the purchase from the liquor store and had understood from the authorities there it would not be considered a public place where he wished to store the liquor. At the time of imposing the fine Magistrate Atkinson had recommended that the matter be referred to the Attorney-General. There was a letter from Simms, Hooker and Drew re some lots against which the owner is delinquent in tax payments. These are still to be held. There will probably be a general tax sale early in the year.

A case of financial responsibility for a man who went to Gravenhurst was tried out as a test case but the township had no luck. Their only resource now will be to get the money from the man who went, as they think he can pay some towards it.

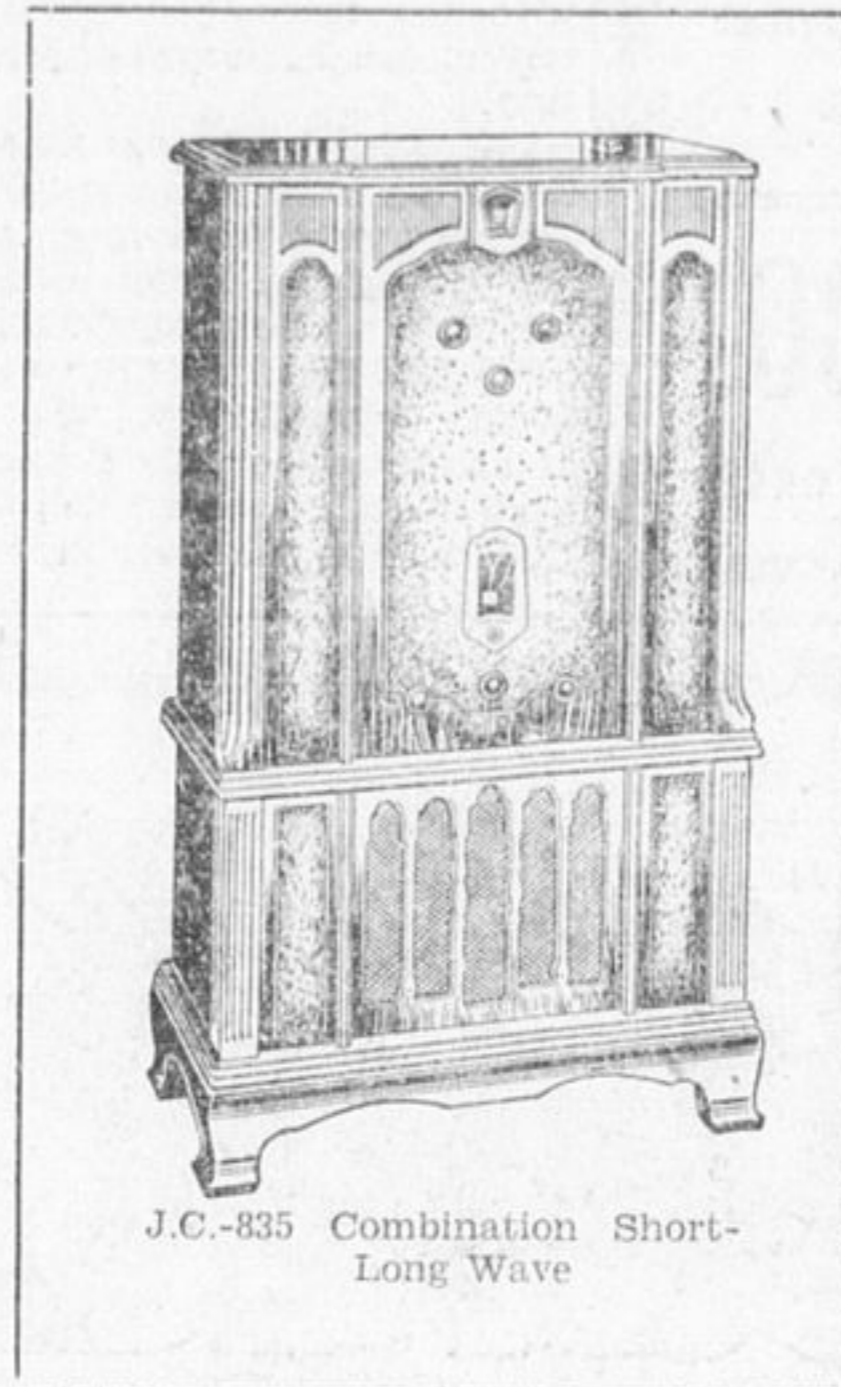
A letter re combustion in furnaces was left over for a later date.

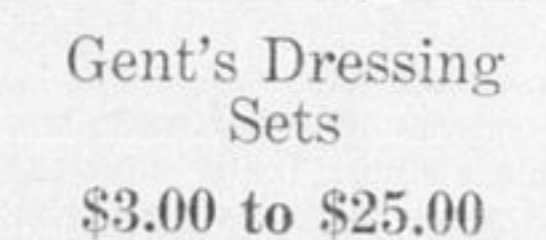

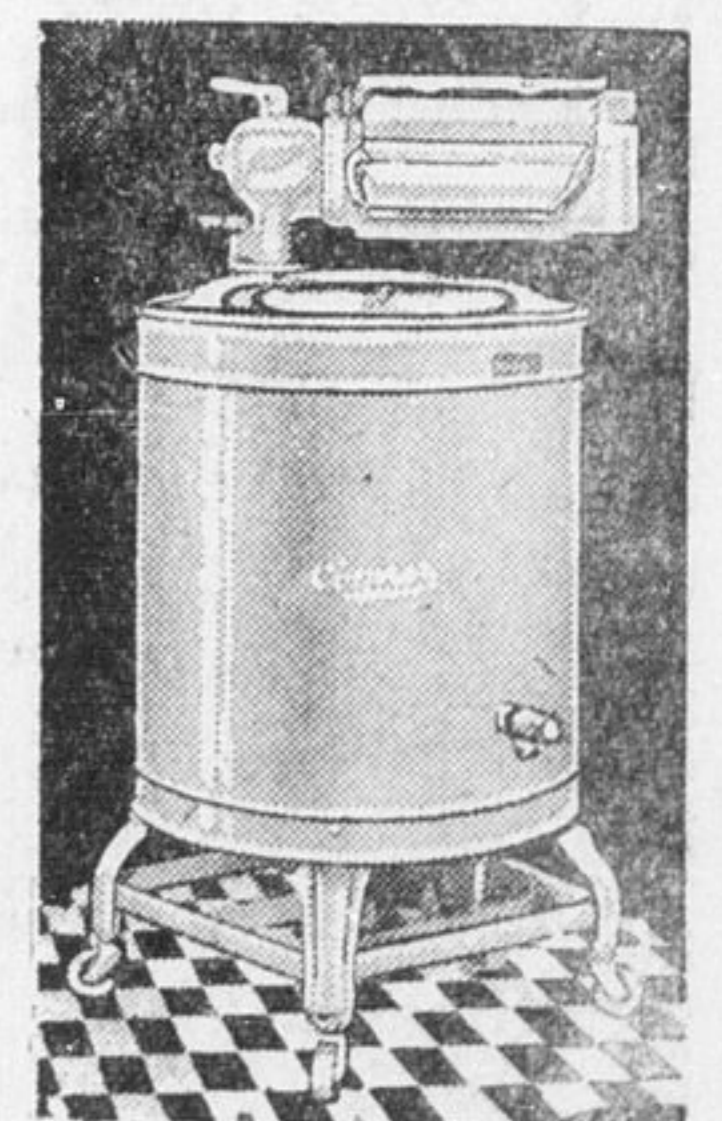
