## Drowned Near Rouyn on Way to Agitate Strike

A despatch from Rouyn on Tuesday of this week says:—"Albert Deschenes, organizer for the Lumberworkers' Industrial Union, was drowned today and two companions narrowly escaped when their canoe capsized in rapids about a quarter of a mile from the junction of the Ottawa and Kenogjiew rivers, not far from Clerion Depot. One of the companions was named Robert Leveseur but police tonight had not ascertained the name of the other. In a borrowed canoe, the three had left here to attempt, police learned, to organize a strike among drive-workers employed by the Canadian International Paper Company along the Ottawa river.  
They set out early today from Clerion Depot to paddle up the Kenogjiew and had only gone a little distance when the fatality occurred. Deschenes attempted to swim ashore and was drowned while the other two men clung to the canoe and were picked up about an hour later by a boat, manned by an Indian. Owing to water of the river being 20 feet above low water level, due to spring flooding, no effort could be made at present to locate the body."

## Town Police Solve Puzzle of Break-ins

Theft of Goods from Warehouses Bring Court Cases. Many Other Charges at Police Court Here This Week.

There was a busy police court here this week with quite an array of cases and considerable variety in the charges. David Hill, of the township of Evelyn, in the Comaught area, was charged with illegally having a still, the charge being made by E. C. Glendenning, R.C.M.P. Provincial Officer. Strickland found the still last week and brought Hill to the local jail. The case was adjourned for a week at least, as Hill had to be taken to the hospital for treatment. He had been acting queerly from the time he was locked up, and police were of the opinion that he appeared to be suffering from imbibing too much moonshine liquor. In any event he was a sick man on Tuesday and was transferred to the hospital for treatment.

Mrs. O. Perrin, Third Avenue, was fined \$100.00 and costs for possession of liquor not obtained on her permit. The local police had a charge of selling liquor against Henry Daches, 167 Birch Street, south. Sergt. Holley and some of the town force raided the place on Monday night, Daches being arrested at the time, but later allowed out on bail. The case was adjourned till next Tuesday when it came up this week.

An ordinary case was dismissed. Two ordinary common drunks were assessed \$10.00 and costs, while two others took thirty days instead.

A charge of driving without a chauffeur's permit was remanded till called on, the accused getting the necessary permit in the meantime.

A week's adjournment was made in a game and fisheries act case laid by Warden Eddleston.

A local citizen was dismissed on a charge of failing to provide for his family, his claim being that he gave them money when he could do but that he was out of work sometimes.

Five different motorists paid \$10.00 and costs each for speeding.

A reckless driving case laid by Provincial Constable Strickland was adjourned for a week.

A prospector encountered by Provincial Officer Strickland while the said prospector had liquor in his pack sack drew a term of three months in lieu of a fine.

Acting Chief R. Paul and Sergt. Holley and their staff cleared up several robberies in town recently. A lad of seventeen was charged in court with the theft of a bicycle and other articles from Marshall-Ecclestone's and also goods from the Ideal Hardware. The police recovered the greater part of the goods. A. G. Carson C.A.S. inspector, spoke on the lad's behalf saying it was a first offence and the boy had been a good lad hitherto. The boy was given suspended sentence on a two-year term when he pleaded guilty to the charges.

In juvenile court the police also had four lads under sixteen for stealing a box of raisins from Gamble-Robinson after a break-in to get the goods. Another lad was charged with receiving stolen goods. The five boys were placed on parole with A. G. Carson, C.A.S. inspector.

Friends of W. H. Wilson were pleased to see him able to be out and around again this week after several months at home from the effects of frost-bitten fingers. It was necessary a couple of weeks ago to amputate some of the fingers on the left hand, the frozen fingers having become infected. Although carrying the one hand bandaged and in a sling "Scotty" is as cheerful as ever and is now apparently well on the way to complete recovery after a painful and uncomfortable time.

## Officers Ontario Command to Visit the Legion Here

Capt. Jules Ferry, of Sudbury, president of the Ontario Command of the Canadian Legion, and Archdeacon McIntosh, of Dundas, second vice-president, are to visit the branches in the North from June 20th to June 24th, and of course Timmins will be among the centres visited.
