Nobody in Court Would Admit Knowing "Rosie"

Basement of New Hotel Declared Public Under Act. Three Men Get Terms for Breach of Liquor Laws. Interesting Evidence in Cases. Other Court Cases.

When the basement of a hotel at the corner of Mountjoy street and Second avenue was declared public for one year and a man sent to jail for three months following Tuesday's police court, it was the straightforward evidence of one of the "customers" of the place that clinched the case for the prosecution.

"This is the witness you wanted to call!" the magistrate told the defence, after the customer had appeared for the prosecution. The man admitted having been in the place when the police raided it on January 26th, had paid for six bottles of beer and had begun to drink one of them.

Another who had had one of the bottles "didn't know who gave him the beer, and didn't know the occupants of the place."

"Do you know a woman by the name of Rosie?" asked S. C. Platus, counsel for the defence.

"No," replied the witness.

"Neither do I," interjected the magistrate.

"Neither do I," echoed counsel.

"Is this the first time you've been in a blind pig?" queried the magistrate.

"No, sir," answered the witness.

"Keep out of them from now on, the bench warned, "or you'll get into trouble the next time."

Boys Remanded for Week

A 15-year-old boy, charged with being drunk, was remanded until next week. His parents in South Porcupine had been notified but did not appear. If his people come to the police station, the lad will be turned over to them, so as not to be kept in the lock-up all week. If they don't call, he will have to accept the town's accommodation until Tuesday.

"I was off the streets," said a well-known Timmins man, "so I didn't think it was necessary," when he was asked why he hadn't appeared in police court last week to answer a charge of vagrancy.

"Oh, yes, I intend to work," he told the court.

"The hardest work he ever does is coming here to tell me about it," said his worship.

The man will appear next week and offer proof that he is no longer a vagrant, or else go to jail. Officers had arrested him two weeks previously for having slept the night in Dr. Moore's office.

Another Younger Man Pleaded Not Guilty to a Vagrancy Charge

Constable Desroches had been in the police office when the man came in, asking to be locked up, since he had no place to go, no money and nothing to eat.

Advises Throwing Out
"Dismissed," said the magistrate, "but throw him out the next time and then he will be a vagrant. These fellows seem to think the police have nothing else to do than look after them."

Jack Sloan pleaded guilty to a vagrancy charge. He had tried to beg 25 cents from a police officer on the street one day, was taken to the station, fixed up with food and a bed, but had no place of any kind to which he could go, so was booked on the charge. He was sentenced to thirty days.

Roland Lachapelle was again remanded on a reckless driving charge laid by Mike Scanlin.

Case of Vasile Stefanec, John Antonese and Petru Guzulak, charged with common assault by Nick Bogdan, was laid over for a week.

Four drinks were offered the chance of paying \$10 and costs or going to jail for 30 days.

A wage argument between one of the partners in a local restaurant and one of his former employees was dismissed. The sum in question was \$2.40. The man claiming the money had been employed at \$10 a week on the "night shift," from ten at night to seven the next morning. He had thought himself badly treated and had quit, without giving his employer any notice.

Published as Warning to Children and Parents

Kenneth Smith, aged seven, and Norman Peterson, five years old, are in hospital at Kirkland Lake, each having suffered a broken leg through an accident on the Noranda road. Sliding swiftly down a path runway, with drifts of snow four or five feet high on either side, the lads on their sleigh were invisible to Steve Posmituk, taxi driver, and as the sleigh shot out onto the roadway he was unable to stop or swerve in time. Those who knew the particulars of the accident say that the youngsters were fortunate to escape with broken legs. The accident might easily have resulted in much more serious injury, or even in death for one or both. The case is quoted chiefly in hopes of impressing on children and parents the danger of playing on roadways or using travelled roads for their sleighs. Car and truck drivers might also note the accident and add accordingly to their watchfulness and effort to avoid accidents by holding down speed at all times and especially when children are liable to be around at play.

Magistrate's Evidence in Case

"What was the name of the woman?" Mr. Platus asked.

"She told me it was Demetri. She said she and another girl lived there and these were her guests. But she didn't know their names and they didn't know hers."

"Poor Bartender, Poor Liar"
Albert Seguin on the witness stand, admitted that he had been released from lock-up following a vagrancy charge, on January 21st. The money found on him was his, he said, and had been sent to him from Emile Lafamme, a friend in Ottawa. He didn't know where the friend lived. He had given the people beer, he said, and they had given him money "for a present for the woman to clean up the house." The money certainly wasn't for the beer, he claimed.

"You're a poor bartender and a poor liar," the magistrate said at the conclusion of Seguin's story, "but I do think the ladies should be charged too."

"Even if he was only a bartender he'll have to take his medicine," Seguin will serve three months and the liquor was confiscated.

Another Gets Three Months

Sabatino Ceneri, whose address has also been changed to Haliburton jail for three months, told the court he hadn't had anything to do with selling liquor. Never sold a bottle in his life.

Deputy Chief Salley told of a raid on 202 Balsam street south where police found 48 pints of beer, 48 empties, and three women. Five, six, seven and eight taxis had been seen visiting the place between the hours of eleven o'clock in the evening and four o'clock in the morning on various evenings. "Customers" entered and those who emerged were usually under the influence of liquor. Ceneri's supply of liquor went up and down with surprising speed. Seven raids on the place at various times had shown, for example, on December 23rd, 129 bottles in "stock"; on December 29th, 33 bottles; on December 31st, 72 bottles, and on January 4th, 77 bottles.

"Worse Than Blind Pig"

Taxis never called there, Ceneri said, but a taxi man did live in the house. There were only one woman and she was the housekeeper, he swore. He admitted being out of work, having only \$9.02 to his name, but said rather hopefully that he could get money from his friends.

"This place looks worse than a blind pig," commented his worship, making it public for one year and giving Ceneri three months hard labour.

George Boucher was another blind-pigger who got three months hard labour. Charged by Provincial Constable George White with selling liquor at 452 Pine street north, Boucher pleaded guilty.

"What sort of place is this?" asked the magistrate.

Believe King Edward VIII Does Not Intend to Marry

The London, England, Sunday Express says that the historic and rich Duchy of Cornwall will be turned over by King Edward to the Duke of York to aid the latter financially in his increased duties as heir presumptive.

This move was viewed in some quarters as the strongest indication the bachelor King intends never to marry, the paper said, for the Duke of Cornwall, since it was established by Edward III, has always been the property of the heir to the Throne.

It was suggested that if King Edward had any intention of marrying he probably would keep it for a possible son and heir, in accordance with tradition.

The income from the Duchy of Cornwall was the sole state revenue of the Prince of Wales. In 1927, it paid him approximately \$365,000.

Will Not be Mild, but Not So Severe as Recently. Likely to be Snowfall Also.

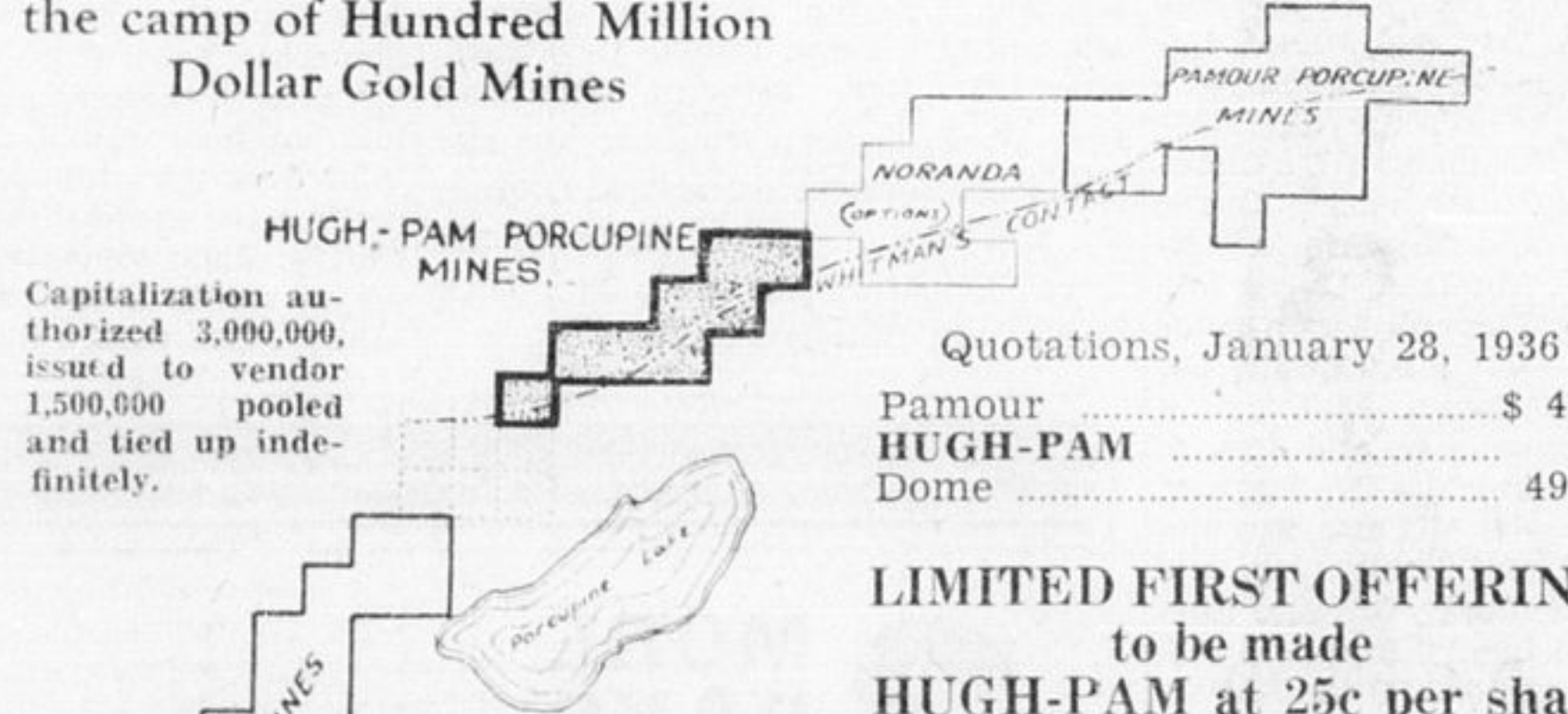
The sky will cloud over within the next day or so, the weatherman predicted this morning, and there will probably be snow. The temperature will moderate, it is expected, although it will not be mild.
