

Obtained \$875 Falsely Receives Nine Months

"This Looks Like a Swindle," Says Magistrate Sentencing A. Lagace. Old Offenders on Drunk Charges Receive Stiff Terms. "Advertising Man" Sentenced to Three Months for Forgery.

For obtaining \$875 from J. P. Roy on a chattel mortgage obtained by falsely pretending to be the owner of goods which, in reality were not his, Arthur Lagace was sentenced to serve nine months in jail by Magistrate Atkinson in police court on Tuesday. The goods mentioned included 12 beds, complete with springs and mattresses, 13 bureaus, chairs and tables. They were in the Victoria Hotel, Schumacher.

in his own handwriting, and which he said he owned, was valued at \$2,030, said Mr. Roy.
J. A. Cousineau, the barrister who handled the matter of the mortgage for Mr. Roy, was a witness. He conferred with Lagace and Roy in his office, he said. Lagace submitted a list of furniture and when asked if he was the owner, said that he was. He said that he had bought the furniture from Mr. Lauzon and showed a cheque with which he purported to have paid for it.
Mr. Cousineau said that the \$875 was made up of the \$790 loaned by Mr. Roy plus his fee.
Charles Holzvack, the owner of the hotel, said that he rented the hotel to Harry Lauzon, who, in turn, leased it to Lagace.
Some of the furniture in the hotel was his. He produced a paper which

listed twelve beds and mattresses, twelve bureaus, chairs and tables. All of that was his, he said. When questioned by Lagace, who conducted his own defence, he admitted that the furniture in six of the rooms did belong to Lagace.
Mr. Lauzon said that he sold Lagace four or five beds and mattresses and some oil cloth but no bureaus.
On the stand Lagace, who spoke very broken English, said that he bought five beds from Lauzon and six more at hardware stores. He admitted, however, that he owned only one bureau.
From the audience Mrs. Lagace got to her feet and said that she knew that all of the furniture listed did not belong to her husband. Some of it that did he sold only thirteen days after he received the money for the mortgage.
Questioned further, Lagace admitted

that such household furnishings as an electric ironer and washing machine, which he told Mr. Roy were his, were re-possessed by the firms from which they were bought when he did not keep up payments on them.
"This whole thing looks to me like a swindle," said Magistrate Atkinson. "Nine months in Halleybury jail."
Old Offenders Sentenced
James Lennon and John Baird were each sentenced to three months in jail. They both were convicted of drunkenness and had two previous convictions against them. Having previously served two terms of three months each for being drunk and having many other convictions against him for the same offence, Charles Ellison was sentenced to four months. A long record coupled with another conviction for drunkenness drew a four month term for George Lefebvre also.

Allen Bell was given the alternative of three months in jail or a fine of \$100 and costs for having wine in his possession illegally. William Alla pleaded guilty to a charge of having beer in his possession illegally and was given the same alternative.
C. J. O'Connor Convicted
C. J. O'Connor, who last week described himself as an advertising man taking orders in Timmins for space around the sides of a map he was going to print, was sentenced to serve three months on each of four charges, sentences to run concurrently.
Three of the charges were heard last week. They were for fraudulently passing cheques when he did not have an account. He was convicted of the three and held on \$100 bail in order to give him a week to make restitution.
On Tuesday he was again brought up, this time on a charge of forgery. He pleaded guilty. In explanation of his failure to make restitution on the other three counts he said that he was unable to raise the bail and consequently not able to get out and get the money together.
Asked to give a reason for forging a cheque on the name of C. W. Nelson, he said that he had no excuse. He needed money for Christmas last year and so had imposed on a friend.
Stolen Overcoat
Mrs. C. S. Clarke said that she hung her husband's overcoat out in the hall outside their apartment over Mark Bowie's store and then missed it. She reported the theft to the police. Asked to identify a coat produced in court, she said that it belonged to her husband.
Constable Guolla said that a call was received from a second hand store in town. The proprietor said that Robert Girard was trying to sell him an overcoat. Picked up by police, Girard said that he bought it for \$4 from a man named "Blackie." He did not know his other name.
The case was clinched when Inspector Olson said that Girard told him that he bought the coat on the day before it was stolen. Sentence was thirty days.

the measure was introduced by Councillors McNeil and McCabe, the wording being given to them by Mayor Bartleman, who gave the phrasing as they wrote it down.
After the passing of the motion Mayor Bartleman concluded proceedings with one of the many indirect digs he aimed during the evening at the three absent members of council.
"I must congratulate the council, small as it is, on the amount of work done," he said. "The amount of work done is apparently in inverse proportion to the number of councillors present."
The letter from the Mine, Mill and Smelter Workers' Union said that the executive of the organization had come to the conclusion that endorsement of the idea of holidays with pay for the miners by the council would greatly assist. It called to the council's attention that the question of holidays with pay had formed an important part in the last election.
Council Resolution
Another matter which called for an explanation from the Mayor was the resolution which was passed by Le Cercle Canadien-Francais and forwarded to the council.
The resolution, which has been printed in The Advance in a previous issue, asked the Mayor and remaining members of council do not accept the resignation of Councillor Brunette. If the left the council, it pointed out, the French people in this town would not have representation. The resolution also said that the Cercle Canadien-Francais considered it unfair that Councillor Brunette was not made chairman of the finance committee.
Councillor McCabe moved that the letter be filed, before Mayor Bartleman launched into his explanation. The council did not break any precedent in not appointing councillor Brunette chairman of finance, he said. There had been a number of cases where the councillor who received the highest vote at the polls was not given that office. Intention was to have Councillor Brunette as chairman of relief in order that he could interpret both the language and the problems of the French relief recipients. The relief committee, today was a much more important committee than the finance, he said.

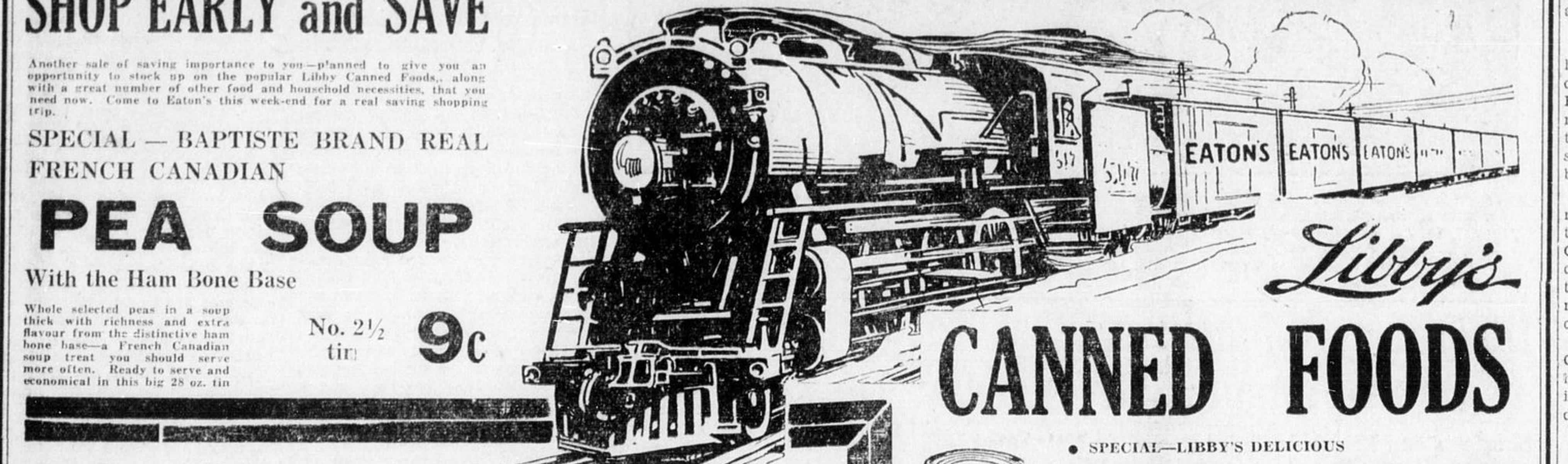
Invitation Declined
