

TEN YEARS AGO IN TIMMINS

From data in the Porcupine Advance Files

The following article appeared in The Advance ten years ago:— "There is growing disposition these days to feel that drastic measures should be taken to deal with those who refuse to work but want instead to sponge on the already well-burdened taxpayers of the town. There have been several calls recently for men to cut wood in neighbouring camps and it has been impossible to fill the need from single men accustomed to bush work who have been getting meal tickets from the town. Following the policy of the town council single men refusing to accept the work offered are cut off the free meal list. While the complaint is made that no money can be made at the wages or rate of pay offered, the general feeling is that these single unemployed would show more good sportsmanship to accept any work even for barely enough to keep going rather than to be a burden on the town which has no responsibility for them except that of humane feeling. It does not increase the kindness felt for these transient single men when they refuse the chance to help themselves without even giving the work a trial. Their arguments are also weakened when it is noted that the orders for men are being filled by bringing men in from Sault Ste. Marie and North Bay. With these others coming in from these outside places there will be a still further burden on the town from the drifters and it is evident that something should be done now to see that groups of these men are not foisted upon Timmins to take away relief from more worthy cases and from bona-fide residents of the town. The matter seems to be one demanding the attention of the provincial authorities to see that neither the transients nor any employers of labour take improper advantage of the conditions to-day. With practically everybody on reduced pay and with so many on no pay at all, there will be no patience with impossible and absurd demands for the wages of past days. At the same time no employers of labour should be allowed to profiteer at the expense of labour these days."

The firemen, however, put up their usual hard and effective battle and kept the blaze from spreading. Had it been given any leeway the fire would have taken the mill and all the other buildings on the property. Most of the machinery and equipment had been transferred to another property but the buildings were of value and there was danger of them being wiped out. The firemen battled fire and smoke for two hours before finally the blaze was conquered. As it was there were several hundred dollars damage to the stockroom and engineer's room in the building where the

fire started. The cause of the fire was not known.

Hollinger Greenshirts Win Their First Game of the Season by Surprising McIntyre 8 to 4

Pressing from the Start the Greenshirts Hemmed in the Miners and Took a Five Goal Lead in the First Period. Proved Good in Front of Goal in Friday Evening's Game.

In a reversal of play the Greenshirts made a great stop for Baker. In less than two minutes, Delmonte got the rubber at centre and passed to Kovalchuk who was in the clear and scored. Hollinger Scores Tying Goal in Last Minute of Game Against Ankerite Bisons on Monday
