John Caveney Given Military Honours At Funeral Sunday

Funeral services for the late John A. Caveney of Sandy Falls who died on Wednesday, Mar. 13, at Christie Street Hospital were held in the Canadian Legion Hall on Sunday.

Mr. Caveney had been employed at Sandy Falls Power station in the capacity of superintendent since 1924. He succumbed from an illness contracted while on active service during the first Great War.

The deceased was born in Manchester, England, 59 years ago, the son of the late Mr. and Mrs. Micheal Caveney. He came to Canada in 1913 and settled in Welland, where he was employed by a manufacturing company.

In 1914 he enlisted and went overseas that same year with the 16th Battery, R.C.A. and was discharged with a disability.

In 1918 he returned to Canada to take a position with the Northern Power Company and in 1924 he was promoted to superintendent at the Sandy Falls power station, holding that position until his final illness.

Surviving are two sons and four daughters, Albert Caveney of 123 Birch St. South, John of Kapuskasing, Mrs. J. M. McKane and Miss Irene Caveney of 123 Birch St. South; Mrs. S. Stogin of Coniston and Mrs. D. Orr of Sandy Falls.

Also surviving are Mrs. T. Hogan, a sister residing at 95 Ross St., a brother Michael, of Toronto, W.P. Caveney, a brother, and Eileen, a sister, living in Manchester, England.

All of Mr. Caveney's children were present for the funeral and previous to the service the body rested at Walker's Funeral Home.

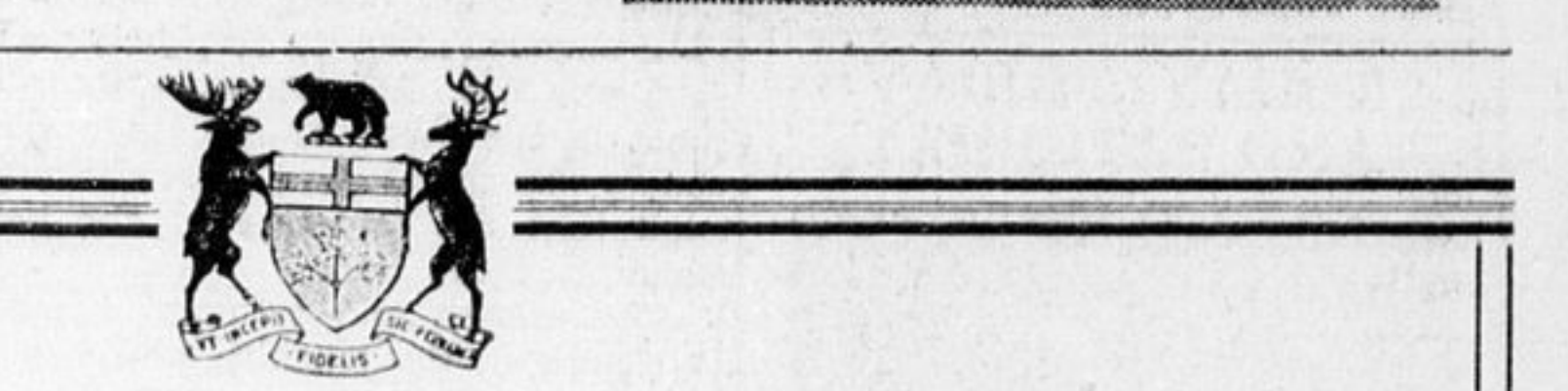
