

ERNIE SCHRITT'S RINK WINSHUDSON'S BAY CURLING TROPHY

The Hudson's Bay Trophy emblematic of the Terrace Bay Curling Club Championship has been won by the rink skipped by Ernie Schritt, with Walt Lemiski 3rd, Marv Lemon 2nd and Don Brand lead. In a ten-end game played last Sunday morning, the Schritt aggregation defeated Rune Ostling's rink by a 16-7 score. On Rune's rink were Charles Biederman 3rd, Irene Ostling 2nd and Dick Lumbers lead. Postponed from Saturday night due to soft ice conditions, the Sunday morning game was played on relatively poor ice despite the postponement.

Schritt drew first blood on the first end with a single point and from there on held the lead all the way. His high score was built up particularly on the 4th end with a count of four and with a five ender on the 7th. Ostling scored two in the 3rd, two in the 5th, two in the 6th and one in the 8th.

DON'T USE DEFECTIVE TOOLS-THEY INVITE ACCIDENTS

Hand tools should be considered defective and requiring repair or replacement

whenever the following conditions exist:

1. Impact portion of tools is mushroomed, chipped or flaked.
2. Head, blade or bit is insecurely fastened to handle.
3. Handle is broken, split or splintered.
4. Screw driver bits are mishapen by breakage or wear.
5. Wrench jaws are spread out of alignment.
6. Tool dressing or sharpening is required.
