DEADLINE FOR INCOME TAX RETURNS APRIL 30 Attention is drawn to the fact that Canadian Income Tax returns must be made by April 30th, after which penalties for late filing apply. Care should be taken in selecting the proper form. When income is over \$3000. or investment income over \$1500. the "T-1 General" form must be used. Persons with income less than \$3000. including an investment income of not over \$100. use either a "T-1 Special" or the new postcard size form known as "T-1 Employees 1947".

Persons filing the postcard type form will be advised of balance owing by the Income Tax Department. All others should remit the balance of tax owing when returns are made. Cash should not be sent when making remittances. All cheques or postal notes should be made payable to the Receiver-General of Canada. "T-l Special" and "T-l General" forms may be obtained at the local Post Office.

POST OFFICE BOXES

All Post Office box rents which were due on March 31st must be paid by April 15th otherwise boxes will be forfeited.
