by the newly elected Hockey Executive.

Dave McDonald (Minor Hockey Administrator) has been assured of a keen interest in townsite hockey for the youngsters. Dave is at present negotiating for affiliation with Hilda's Peewee Hockey Association of Port Arthur. This would automatically place all local minor hockey players on the Chicago Black Hawk negotiation list and permit minor teams to procure equipment at cost price.

A letter was received from Mr. F. W. Rankin, (Secretary-Protem) of the Thunder Bay Amateur Hockey Association outlining requirements for the entry of an intermediate team in the T.B.A.H.A.
