NEW POST OFFICE HOURS

Beginning on Monday, November 21st the Money Order and General Delivery wickets at the Post Office will be operated during the following hours: Money Order wicket 9:00 a.m. to 11:00 a.m.; 12 noon to 4:30 p.m.; and 5:30 p.m. to 6:00 p.m. General Delivery wicket from 8:30 a.m. to 11:00 a.m.; 12 noon to 4:30 p.m.; and 5:30 p.m. to 6:30 p.m. Both wickets will be closed Wednesday afternoons and Sundays. Lobby hours will remain the same as at present 8:00 a.m. to 8:30 p.m. sharp. The above schedule has been developed in order to make it more convenient for all Post Office patrons to receive their mail during the day and the public is requested not to ask for mail or stamps after the wickets are closed.
