PARKING BY-LAW IS ENACTED

The following are the main points of a Parking By-Law which has recently been enacted by the Trustees of the Improvement District of Terrace Bay.

"No person shall park a vehicle on any street or part of a street, between the hours of 2:00 a.m. and 7:00 a.m. from November 1st to April 30th of each year.

No person shall park any vehicle of any kind in any of the following places in the Townsite of Terrace Bay.

1. Within an intersection.

2. Within 10 feet of a fire hydrant.

3. Within 20 feet of an intersection where busses take on or discharge passengers.

4. On any Street or Highway in such a manner as to obstruct traffic. The members of the Provincial Police Force having jurisdiction within the Improvement District of Terrace Bay, shall enforce the provisions of the By-Law.

Penalties for violation have been provided."

The main reasons for the enactment of this By-Law being to enable the snow ploughs to get through all thoroughfares unobstructed when keeping them clear and also in the case of a fire, to enable the fire truck to manoeuvre without delay.
