BENEFIT PLANS (Cont'd from Page 1) he might be medically unacceptable as a risk on other insurance coverage.

Dividends in term insurance of this nature are returnable to employee in the form of "skipping" of premium payments for a certain number of months each year. These have varied from 4 to 6 free months in the past three years. It is expected that perhaps 5 months this year will be premium-free. This is governed to great extent by the mortality rate among all employees of the Corporation in the mills throughout Canada and U.S.A. A considerable saving in insurance premiums (already very low in cost) is therefore passed on to all employees. The question "what happens when I reach 65?" is an important one. Here one of the finest features of our group insurance coverage becomes evident. When an employee retires and becomes a "life member" of the Corporation he can continue his group insurance at the same rate as he paid when on the payroll. This is a remarkable feature and a very important one in planning an estate to take care of his loved ones left behind at the time of his passing. Of course, permanent disability benefits are no longer payable after age of 60. as in all cases of term insurance where permanent disability is allowed as a reason for payment of insurance, age 60 is the maximum age at which such benefits can be allowed.
