OF INTEREST TO THOSE OCCUPYING BUSINESS PREMISES ON SIMCOE PLAZA BY-LAW Number 63

A By-Law requiring the removal of snow

and ice from sidewalks.

1. A. "Occupant" shall mean Owner or Tenant. B. "Access Sidewalk" shall mean a sidewalk running from Simcoe Plaza through the Boulevard area adjacent thereto.

C. "Person" shall include a Corporation.

- 2. The occupant of every parcel of land or premises which fronts or abuts on the side of any street upon which there is a sidewalk shall within four hours after any fall of snow, rain or hail shall have ceased, remove or cause to be removed from off the portion of the sidewalk opposite to such parcel of land or premises the snow and ice resulting from such fall of snow, rain or hail.
- 3. The occupants of parcels of land or premises nearest to an access sidewalk shall in the manner aforesaid remove or cause to be removed snow and ice from such sidewalk.

4. Any person convicted of a breach of any of the provisions of this By-Law shall upon conviction be liable to a penalty not exceeding (exclusive of costs) the sum of FIFTY DOLLARS (\$50.00) for each offence recoverable under the Summary Convictions Act.
