Canada. After this date no further interest will be paid. Interest coupons due November 1st, 1954 and all coupons dated later than this must be attached to the bonds when they are presented for payment. Payment will be \$101.26 for a \$100 bond (and for other denominations accordingly). This payment includes \$1.26 which is interest at 3% from May 1st to October 1st-the period since the last coupon became payable.
