President - Alex Sinkins... Presides at meetings of the board and members. Presents the annual report of the board to members.

Vice President - Jim Corrigan .... Acts in the Presidents absent or disability. Board of Directors....

Ab Farrow, Walter Anderson, Jim Rowley, Al Stevens, Francis Gaulin, ....

Have general management of the credit union, sets its policies, approve all applications for membership, sets the interest rate (never more than 1% per month on the unpaid balance) and declare the dividends. They meet monthly, and hold additional meetings if necessary.

Secretary - Adam Zyri....

Keeps minutes of meetings of the Board and members.

Treasurer - Bill Baillie .... He is the active manager of the Credit Union. He keeps the books, makes the financial report, and is in charge of the receiving and disbursing of the funds. Most of the members come to the treasurer with their financial problems, and he usually transmits loan applications to the credit committee. On him falls most of the work, so he may be paid for his credit union work, although other members of the board and committeemen volunteer their services.

The Credit Committee ....

Ken Mackay, Vern Hopper, John Mikus. Supervises all loans to members. Applications are made in writing and must tell the purpose of the loan, security offered, and any other data required. The credit committee meets regularly, as often as necessary to approve loans.

The Supervisory Committee .... Harry Goodfellow, Don Brearley, Willard Vezina.

The Supervisory Committee is the "Watch Dog" of the Credit Union, it keeps an eye on the operation of the Credit Union, examines the affairs of the Credit Union, and report to the membership at the Annual Meeting. It has the Power to suspend Officers and Committeemen if it deems necessary.
