FIRE PREVENTION NEWS

Lost \$3,120 in Fire Collect Only \$40.

Montreal, Oct. 15 -- A New York couple who lost personal effects they valued at \$3,120 in a 1947 fire at a resort in the Laurentian town of Ste. Adele, can collect only \$40 damage under a Quebec law.

In a superior court judgment, Mr. Justice Andre Montpetit said: "keepers of inns, boarding houses and taverns are not bound to make good to any guest any theft or damage to goods or property to their houses to a greater amount than \$40" unless valuable had been stored with the hotel for safekeeping.

Mr. Justice Montpetit then ordered Alpine Resorts, Ltd., owners of the hotel to pay Mr. and Mrs. John A. Ganley \$40.
