HAVE YOU A FOREST TRAVEL FERMIT? THE FOREST FIRES PREVENTION ACT:

9. (4) No person shall enter and travel about in a forest travel permit area during a fire season except under and in accordance with the terms and conditions of his forest travel permit and in accordance with the regulations. F.F.P.P. Amendment Act 1955.

WHEN A FOREST TRAVEL PERMIT IS REQUIRED: 1. A Forest Travel Permit is required to cover all travel in the Geraldton Forestry District for fishing, camping and canoe trips, prospecting and berry picking or for any other purpose in which woods travel is required.

2. A Forest Travel Permit is necessary to cover the lighting of camp fires for any purpose anywhere in the District.

WHEN A FOREST TRAVEL PERMIT IS NOT REQUIRED: 1. To travel along public roads or to use roadside parks and picnic areas when no side trips will be made into a forested area enroute.

2. To travel between an established place of summer residence and a town or village.

3. By persons visiting their summer homes over weekends, etc., who do not intend to leave the lake on which their camp is situated.

PENALTIES: 26. 1. Every person who disobeys or refuses or neglects to carry out any of the provisions of this Act or any regulation or order made thereunder shall be guilty of an offence and on summary conviction shall be liable to a fine of not less than \$25 and not more than \$300, and in default of payment may be imprisoned for a term of not more than three months, or to imprisonment for a term of not more than three months, er to both fine and imprisonment, and such person shall be liable to the Department for any expenses incurred by it in endeavoring to control or extinguish any fire caused by or resulting from such disobedience, refusal or neglect.

The following have been authorized to issue Forest Travel Permits in Terrace Bay: H. McLeod, Terrace Bay and the Ontario Provincial Police, Terrace Bay.
