"KNOW THE ANSWER" CONTEST -

The following are questions and answers for March: -

1. QUESTION - What is a disabling injury "Frequency Rate?"  
ANSWER - The number of disabling injuries per million employee-hours of exposure.
2. QUESTION - What is a disabling injury "Severity Rate?"  
ANSWER - The number of days charged per million employee-hours of exposure.
3. QUESTION - What is the maximum speed limit on our mill road through the parking area?  
ANSWER - 20 miles per hour.
4. QUESTION - In every case of injury no matter how slight, what two things should be done?  
ANSWER - Get First Aid promptly and report details to the foreman without delay.
5. QUESTION - Should a seriously injured person always be rushed to the hospital?  
ANSWER - No! In case of internal or spinal injury or serious fracture, the move should be supervised by doctor, nurse or qualified first aider.
6. QUESTION - What action should be taken when a person is injured or takes seriously ill while in the mill?  
ANSWER - Phone 222 and give full information to the operator who will take it from there.
7. QUESTION - What does the switchboard operator do when advised of an emergency illness or accident?  
ANSWER - Notifies Plant Nurse (if on duty); arranges for ambulance; notifies doctor; makes other special arrangements if necessary.
8. QUESTION - What are three things to remember when lifting?  
ANSWER - Get a good grip; keep the back straight; lift with leg muscles.
9. QUESTION - Name four kinds of work on which goggles should always be worn.  
ANSWER - Grinding; chipping; drilling; where there's danger of chemicals leaking, dripping or splashing.
10. QUESTION - If we are unable to correct an unsafe condition what should we do?  
ANSWER - Report it immediately to our foreman or supervisor.
