# INCOME TAX EXEMPTION FOR APPROVED RETIREMENT SAVINGS FLAN CONTRIBUTIONS

The Canadian Income Tax Act was amended last Spring permitting individuals, at their discretion to deduct from taxable income any contributions they may have made under a registered retirement savings plan up to a specified limit. Whether an individual should take advantage of this form of income tax relief, or not depends on whether he is prepared to abide by the conditions under which such deductions are permissable. Because of the personal nature of this proposition, it is suggested that employees get the advice of the insurance agent or government annuity representative involved before declaring their intention.

If you qualify and wish to claim such a deduction for 1957, you must declare your intention of doing so on the form your Insurance agent can supply no later than December 31, 1957.
