If the approximate register tonnage is found to be in the immediate neighbourhood of 10 tons, the owner should apply to the nearest Registrar of Shipping to arrange for formal tonnage measurement by a Government Measuring Surveyor of Shipping to determine whether the vessel should be registered rather than licensed.

5. Vessel Licenses may be obtained free of charge from any Customs office. The owner completes a Declaration in exchange for which the Customs officer furnishes him with a Vessel License, bearing a Customs Port Number and serial License Number. The License Number remains unchanged throughout the period of any particular ownership. When ownership is transferred, the old License is cancelled and a fresh one, bearing a new number, is issued to the new owner. 6. Marking of licensed vessels is highly important, as the main purpose of licensing is positive identification through a system of numbering uniform throughout the country. Vessels are to bear figure-letter-figure groups composed of the Customs Port Number followed by the License Number. The groups should be marked in characters of 3 inches in height or more, on the port and starboard bows, and on the stern. On transfer of cwnership, the old number is to be replaced by the new.

## ESSEL LICENSING INSTRUCTIONS

1. Vessels not exceeding 10 tons register tonnage propelled by inboard or outboard motors of <u>10 horsepower or more</u> require to be licensed. Vessels over 10 register require to be registered. The Small Vessel Licensing Regulations provide a penalty for failure to license and mark vessels where required.

7. Vessel owners will also require to comply

2. The Regulations apply both to commercial vessels and to pleasure craft, including vessels operated and permanently maintained in Canada by foreigners. As they also govern any craft for hire to which a customer attaches a motor of 10 H.P. or more, operators of boat liveries might well license and mark gertain of their vessels for this purpose.

3. Exempt from registry and licensing are canoes, skiffs, rowboats, small sailboats, and vessels propelled by inboard or outboard. motors under 10 horsepower. However, the
