whom will be elected by the people of the Town. In order to qualify for any of the above offices, the following requirements must be met:

- 1. The person must be on the voter's list and
- 2. Must be an assessed householder (Householder: A person who occupies and is assessed as owner or tenant of a dwelling or apartment house or part of a dwelling or apartment house separately occupied as a dwelling).
- 3. Be a British Subject.
- 4. Be 21 years of age.
- 5. Must not be disqualified under this or
