MUNICIPAL NOTES ON NOMINATIONS

In the forthcoming elections, which will mark the change of local administration from appointed to elected representatives, nominations for a Reeve and four councillors will take place not less than seven days before Election Day. The exact date of Nomination Day will be set by the Municipal Board in Toronto and will be announced at least six (6) days in advance by the Town Secretary-Treasurer who will be the Returning Officer.

Nomination Meeting shall be called to order by the Returning Officer and Candidates for each Office shall be proposed and seconded. Every nomination shall be in writing and state the name, residence and occupation of the candidate, and residence and occupation of proposer and seconder, both of whom shall be Municipal electors and present. Nominations shall be filed with the Returning Officer within one (1) hour from opening of Nominations Meeting. When the proposed Candidate is not present the nomination paper will not be valid unless satisfactory proof is submitted to Returning Officer that he consents to be so nominated.

Name, residence and occupation of all nominees must be posted up by Returning Officer at the Nomination Meeting or before 9 P.M. of same day. A candidate may resign from one or more offices by filing resignation in writing and in default he shall be deemed to be nominated for office for which he was first nominated. After the Nomination Meeting the Returning Officer will post up in the Municipal Office the name, residence and occupation of every person nominated for the respective offices. Before 9 P.M. of following day every candidate shall file with the Secretary-Treasurer,

1. Declaration of Qualification
2. Oath of Allegiance.
3. Certificate from Secretary-Treasurer that there were at time of nomination no unpaid taxes for any preceding year, on land or business.

QUALIFICATIONS FOR REEVE AND COUNCIL

1. A Householder residing in the Municipality, or rated on the last revised Assessment Roll. A Householder means the person who occupies and is assessed as owner or Tenant of a dwelling.
2. Entered on last revised Voters list as qualified to Vote at Municipal Elections.
3. A British Subject and has taken the Oath of Allegiance.
4. Full age of 21 years.
5. Not disqualified.

Presenting the trophy, Mr. D.A.Locking, Principal of the Terrace High School, mentioned the fact the cup had originated in Schreiber and how the new schools along the North Shore of Lake Superior had been included in it's competition as they had come into being.

Master of ceremonies Jack Stokes, on behalf of the Knights of Columbus, St.Edward's Council, who had sponsored the Oratorical contest, expressed their thanks to the students for their efforts and the teachers or principals who had travelled, some of them a considerable distance, to accompany their school representatives. These were:- Mrs. Carton of Marathon, Mr. Locking with the Terrace Bay group, Mr. Meek with the Schreiber contestants and Mr. MacKay with the Nipigon-Red Rock class. Mr. Stokes also thanked Miss Pat McCann for the musical interlude she had provided during the evening's performances.

Along with the trophy James Farrell received the Knights of Columbus first prize in the Junior group of the Grades nine and ten students, and second prize was awarded to Amy Marie Simpson of the Nipigon Red-Rock School. These awards were made by Mr. M.Nicol, Deputy Grand Knight.
