J. FERRIER ADDRESSES HORTICULTURAL SOCIETY

A highly interesting meeting was held Friday evening in the Recreation Centre's meeting room by the Terrace Bay Horticultural Society when Mr. John Ferrier addressed the members on future plans for facial improvements to Terrace Bay and its immediate vicinity. Points of local interest were thoroughly discussed, many of them particularly for the members concerning beautifying shopping, Recreation and Hospital frontage and parking areas; several areas will be leveled and cleared to present a glade rather than the present bushy appearance.

The Board of Trustees, which Mr. Ferrier presently heads, is most enthusiastic about any spots the Horticultural Society wish to improve and they are willing to discuss any plans and suitable working arrangement.

Mr. Ferrier also stated much activity would be seen with highway work this summer

and a great deal of face lifting is under discussion with the overpass, the Railway approach and the highway in this vicinity. Plans were also being made to move the Senior ballfield adjacent to the Mill road, leaving the present ballfield for High School improvement. Much had been accomplished on the Public and Separate School grounds recently.

Vice President Mantey thanked Mr. Ferrier for his interesting and informative talk.

Mr. Mantey chaired the meeting in the absence of President Mr. F. Ginn and, following minutes and financial statement by the Secretary Mrs. M. Middaugh, mentioned approximately 108 members with a short time still open till the end of March for new members if they wished to take advantage of the premiums available. Mrs. Pluta and any member of the executive will accept memberships. Mrs. Hubelit is taking orders for fertilizers which should arrive about the first week in May.

HOME & SCHOOL MEETING HELD IN SCHREIBER

Mrs. J.A. Taylor of Toronto of the Secondary Schools Home and School Associations of Ont., presided at the organizational meeting of the Schreiber Association on March 16th. Mrs. Taylor said she was honoured to be present at this meeting since it was the first such association in Thunder Bay district, including Fort William and Port Arthur. She stated it was customary for the school Principal to preside at such occasions but Mr. Meek had sent word he was too busy to attend. Mr. Rao was the only member of the staff present, Miss Summers and Mr. Thorpe also being engaged elsewhere. Mr. Meek stated he and his staff were in favour of the organization but, because of pressure of work, could not become too involved.

Mrs. Taylor said the objective of the association is the education and welfare of children; it is not a fund-raising activity and differs from elementary school associations in that the work is WITH the students and not FOR them. It is obligated to hold four meetings a year but may hold more if so desired; there are no set programmes; it is advisable to have student representation on the executive; it is non-commercial, non-partisan, non-racial and non-sectarian.

The motion to organize a Home & School Association was made by Mrs. S. Chicoine, seconded by R.C. Skinner; the motion to name it the Schreiber High Home & School Assoc., was made by Mrs. C. Duggan, seconded by Mrs. R. Kragero; Membership fees were set at \$1.00 and regular meetings will be held the third Monday evening each month.
