HAS BEEN FINANCIALLY
"ADOPTED" BY THE HI-C
CLUB OF THE COMMUNITY
CHURCH AND REV. AND
MRS. J.R. ANDERSON**

The Hi-C of the Community Church and Rev. and Mrs. J.R. Anderson have financially "adopted" Kim Choon Shik, an 8-year-old Korean boy through Foster Parents' Plan, Inc., P.O. Box 65, Station B, Montreal. The foster parents have promised to contribute \$15 a month toward the child's support for at least one year.

Choon Shik's home is an orphanage. His memories fade slowly but they are these. He once lived with his own mother in a small room in Taegu. He cannot remember his father. He and his mother left Taegu and journeyed by train to Pusan, a great seaport city on the south coast of Korea and where the orphanage is. Somehow he was separated from his mother in the crowded streets. Choon Shik cried and wandered until his small legs would scarcely carry him further. At last a policeman found him and brought him to the orphanage after a fruitless search for the mother. No public effort to discover her was successful and nothing has ever been heard of her since that unhappy day.

He did not know his birthday. His age was estimated and the day he celebrates as his birthday is that of his entrance into the orphanage.

Choon Shik is in the third grade of primary school and is a good student. He is also active in sports and plays on the class soccer team. He is patient and diligent in all the work required of him, whether it be studies or helping keep the dormitory tidy. The teachers and the officials of the orphanage feel that he is going to be a very fine young man.

BEARS POSE PROBLEM FOR CAMP OWNERS ETC.

Recently the Game and Fisheries Act was amended making bear a game animal, thus resulting in seasons being established and making it mandatory for a person to be in possession of a licence to hunt and kill bear. However, nothing in the Act prevents a person from destroying one of the animals on his own lands in defense or preservation of his property by any means at any time.

A few helpful precautions to take in discouraging bear from invading your private domain are:

1. Dispose of all garbage in an incinerator or public disposal site.
2. Keeps garbage containers clean and disinfected.
3. Boats that have been used for fishing should be washed thoroughly after each trip.
