 Hydro, Township and Recreation were read and passed for payment. By-Law 138 on the Industrial Area was passed as read, wherein the Township would purchase for the sum of One Dollar each from Kimberly-Clark Corporation, two blocks of land, as five percent of the proposed area, which must by law, be deeded for parks, trees etc. The lots in this area have all been surveyed and ready for sale, with a few already sold. As soon as they are sold they are assessed by the Town. Water and power will be supplied, moving the water along as they are empowered. Buildings in this area must be orderly and not a series of shacks.

By-Law 99 was amended as By-Law 99A to ratify errors in the Lands and Titles Office correcting the original survey errors.
 Written agreement to sell the 75 acres to the Township for the Trailer Court and Swimming area was received from Kimberly-Clark Corporation. Reeve Ferrier recommended an immediate survey of this area, bringing in the results to the next meeting.

Councillor Gilles brought in a request from the School Nurse for disposable needles and a card index; both items were duly granted by Council.

Councillor Duncan reported on a meeting of the Police Committee held with Chief Constable Billings.

Reeve Ferrier reported on a slight delay in the construction of the Utilities Building. He further displayed for Council plans submitted by Mr. Joe Adamo for his 23 unit Motel, lobby and restaurant which, subject to the Fire Marshal's Code and pending electrical approval, were agreed upon. In closing Reeve Ferrier noted the dates set for nomination and elections as, Nominations for offices of Reeve and Councillors on Monday, November 27 from 7.30 to 8.30 P.M. in the large meeting room of the Recreation Centre, and elections, if required, to follow on December 4, 1961. Nominating of one Public School Trustee is to take place on Thursday, November 23 at the Recreation Centre from 7.30 to 8.30 P.M.
