Brearley for a three year term.

Recommendations of the Board of Directors were presented and duly moved that: 1 - (4½%) Four and a half percent dividend be declared on shares for 1961. 2 - Members One Dollar League dues be paid by the Credit Union. 3 - A Delegate and alternate be sent to the Ontario Credit Union League Convention in Windsor, in March 1962. 4 - Five Percent of net profit be allotted for the Education Fund.

Introduced by Mr. H. Miles, President of the Lakehead Chapter who also brought greetings from the three Credit Unions of the Chapter, Mr. H. Dixon expressed pleasure in attending the meeting in Terrace Bay, and extended the greetings of the Lakehead Chapter of the Credit Union.
