KIMBERLY-CLARK EMPLOYEES CHARITY FUND HAS SUCCESSFUL YEAR

The 1961 financial statement of the Kimberly-Clark Employees! Charity Fund appears elsewhere in this paper. It shows that \$5,636.50 was distributed by KC-ECF to worthy charities during the year. This is an increase of more than \$600. over 1960's total; the result of new members signing up and of old members increasing their contributions.

In the near future all Kimberly-Clark employees who are not members of KC-ECF will be canvassed. At present approximately 80% of the employees are members. The Board of Directors is striving for 100% membership.

RULES:

1. Children must attend the party for their age group ONLY, and according to their

age on September 1st.

2. NOTES MAY NOT BE EXCHANGED FOR GIFTS. Children must receive their gifts in person. IF THEY ARE TOO SICK TO ATTEND, parents may send a note, but the gift will be held at the Recreation Office for collection, after all notes have been checked.

THE NOTE MUST STATE THE NAME AND AGE OF

THE CHILD.

3. Children must receive gifts in person, and at the party for their age group.

4. Children in the 2-5year group should bring shopping bags for mitts, coats and hats.

ELECTION RESULTS

Once again the Municipal Elections are over. Out of a possible 749 eligible, 63.42% or 475 voters exercised their right. Des Evans-Smith headed the poll with 364 votes, Angus Fraser tallied 279, J. Wellings got 237 votes and a 235 tie between M. Campbell and A. Valiquette was broken on the flip of a coin resulting in Township Secretary Treasurer F.W. Strutt casting the deciding vote in favour of A. Valiquette. Elected by acclamation J. Heenan will act as Reeve on the above named Council.

DID YOU LOSE YOUR VOTE?

Did you lose your vote by spoiling your ballot? Twenty-three persons lost their vote on Monday in Terrace Bay because they did not mark their ballot properly.

The following reasons make a ballot in-

eligible to be counted:

1. Using any mark other than a simple cross wholly within the space provided.

- 2. Making a cross on the wrong side of the candidate's name. The correct side is the right hand side.
 - 3. Using your own pencil.

4. Encircling the candidate's name.

5. Making any mark on the ballot other than a simple cross with the pencil provided.

The reason for these rules is so that no ballot may be identified.
