

SCHREIBER COUNCIL INAUGURAL MEETING (From Pg. 1)

Mrs. W.G. Furlonger - ratepayers' representative to the Board of Health; J.P. Guina - ratepayers' representative to the citizens' rink committee; Mrs. Inez McCuaig - ratepayers representative to the Public Library for a three year term. The Treasurer's bond was inspected and found in order, according to Municipal Act.

By Law 398, for the borrowing of \$40,000.00 from the Bank of Montreal to carry on Town business pending collection of taxes was passed.

The reeve and clerk were authorized to make all fixed payments and regular meetings were set for the second Monday of each month at 7 P.M.

The library grant was set at \$1,200.00 and rental at \$800.00.

Reeve's salary was renewed at \$250.00 and councillors at \$150.00.

Standing committees were named by the reeve, the first named chairman: Finance - J.P. Guina, F.W. Harness; Property - J.P. Guina, J.M. McGrath; Roads and Bridges - F.W. Harness, I.M. McCuaig; Water Works - I.M. McCuaig, J.M. McGrath; Fire Dept. - J.M. McGrath, F.W. Harness; Police - Reeve D'Arcy; Building Permits - J.P. Guina.

A cheque, sent by Mr. W.A. Mullins, for water rate in full for 1962, less a disputed \$2.50, was accepted, with Mrs. McCuaig recorded as opposed.

Reeve D'Arcy and Councillor Harness were appointed to hold a joint meeting with the C.P.R. and Department of Highway officials, re subway deepening and pedestrian walk-through.

Mr. Guina stated the furnace for the fire hall is expected on January 20th and will be promptly installed by the Gauthier Brothers.

Mrs. McCuaig stated definite word had come of the result of the special Second Commonwealth Study conference in Schreiber.

A letter of protest was sent to the C.P.R. regarding the undue halting of trains on the west end crossing, and prolonged and unnecessary whistling at this point, which provokes and disturbs area residents.

Congratulations were sent to Mr. and Mrs. J. Corbett who recently celebrated their fiftieth wedding anniversary. Mr. Corbett was a former Town Councillor.

After general discussions of several problems the meeting adjourned at 11 P.M.

Public Relations and Town Planning - Parks-Liason with Chamber of Commerce - D. Evans-Smith and A. Valiquette; Fire Protection and Public Health and Welfare - A. Fraser and D. Evans-Smith.

Considerations for the year 1962 were listed by Reeve Heenan as: Utilities - To further investigate possibility of converting to high voltage distribution system; Rental scale for Utilities Building; Consider new hydro rates for consumer due to amalgamation - re J. Tarling; Office hours for new building - Possibly 9.00 A.M. to 5.00 P.M.

Public Works and Sanitation: Landscaping (Kenogami Road, etc.); Extend Lakeview Boulevard through to Superior (sewer, water and road); Consider purchase of own spraying machine and chemicals; Work to be done on

sewage disposal area.

Planning: Purchase of land and development of park area.

Immediate arrangements were made for the Fire Committee to hold their monthly meeting with Chief Constable Billings on his request and the Fire Committee agreed to meet in the near future with Acting Fire Chief Hofland.

ON DISTRICT HIGH SCHOOL QUESTION -- WHAT'S BEST FOR THE STUDENTS?

On Page 1 we report on the latest development in the District High School Question.

Our queries have elicited the information that the Schreiber and Terrace Bay High School Boards can come to no agreement on the site of the proposed school. A 70-30 percent split on the Building, Maintenance and Transportation costs offered by Terrace Bay has been rejected by Schreiber because the weight of public opinion, they say, is against having the building in Terrace Bay.

The Department of Education, leading educators, High School teachers and many residents of both towns are agreed that our High School age youngsters will be provided with better facilities and a more extensive curriculum if one High School is built to service both towns. Has public opinion really had a chance to make itself heard? Is the ultimate goal the prestige to be derived from having the building itself in one town or the other, or is it what will be best in the long run for our youngsters??

Could anything be gained by having a district mass meeting at which time the School Boards would air their views and public opinion be given a chance to assert itself openly?
