SCHREIBER HOTEL BURNS TO GROUND

The Mayfair Hotel in Schreiber owned and operated by Mr. N. Linkewich, was completely destroyed by fire on Monday morning.

Loss estimated is approximately \$50,000.

The Mayfair Hotel was built 15 years ago.

The fire was first discovered by Mr. F. Auger who was making daily milk delivery, at 7:45 in the morning, and noticed the building gutted by smoke, entered and aroused the guests, then called the Schreiber Department.

Arriving on the scene the Schreiber Dept. and Terrace Bay Fire Dept. managed to keep the fire from spreading.

The Hotel collapsed at 9:30 and the small restaurant was gutted with smoke, so had to be destroyed too, in order to save the theatre.

SCHREIBER COUNCIL QUOTES

Legal action will be taken to collect all back taxes. This was decided at the regular February meeting, after reviewing a list presented by clerk R.A. Skinner. It was also agreed that all unpaid thawing cheques must be settled before the facility can be used again.

The CPR's offer for land will be accepted provided it is covenanted into the deed that the natural watershed will be protected.

Inquiries regarding licenses for dog kennels were filed for consideration.

Mrs. McCuaig was delegated to present the municipality's silver cup to the New Year baby.

Complaints from residents regarding garbage pick-up and snow ploughing were dealt with.

The school boards and a store presented protests against the subway, asking council to secure safer passage and, that the extra height be added so that trucks do not need to tranship deliveries for the store.

A resident's plea that a minor car accident was due to condition of streets was disallowed.

Council concurred with a complaint regarding the hazard to school children and pedestrians presented by shoppers at a local store who use the whole sidewalk rather than specified entry and exit. The sidewalk is for pedestrian use only.

Mr. Dawson, of the Children's Aid, stated that he would endeavour to meet with council to discuss common problems. On March 12th Geraldton's communication meeting of Thunder Bay, Rainy River and Kenora representatives will be held there on March 9 to discuss assessment matters.

An agent would be in Schreiber shortly to inspect and offer advice on the parking meters.

W. Weaver, Kinsmen representative, spoke to council on the possibility of showing Saturday afternoon movies to children in the town hall.

Council considered sending delegates to conference at Quetico.

An invitation was also received to attend a regional cemetery conference. Councillor Guina suggested, that rather than pursue inquiries regarding building a vault for winter use in the cemetery, the town buy a jack hammer. This will be considered later.

The accounts this month included \$420.81

for town wards and dependents; high school-\$5,100.00; public school-\$3,400.00; water works dept.-\$611.11 and general-\$10,910.00.

Reeve D'Arcy welcomed councillor J.M. McGrath attending his first meeting after a long illness. Councillors I.M. McCuaig and J.P. Guina, and clerk R.C. Skinner were present -councillor F.V. Harness absent.
