It was decided to seek the advice of a consultant engineer on water pressure problems.

Notice was received from Judge A.H. Dowler re the court of revision, that the appeal against assessment by Donald and Patricia Beno had been denied.

The request by the Chamber of Commerce was refused by the council since the budget has already been drawn up. This will, however, be filed for later consideration.

A grant of one mill was made to the volunteer fire brigade with the usual vote of appreciation for the services rendered the community.

Permission was granted to install an automatic fire warning in the fire hall for Spadoni Firm at their expense.

The licensing of a dog kennel was deferred for further consideration and the present dog by-law revised.

Tax arrears in excess of \$30,000. will be collected. Those concerned have until April 2 to make arrangements after which all accounts will be placed in the collector's hands.

A lengthy list of suggestions for improvements in the town was received from a ratepayer and a note of thanks from Mr. and Mrs. Ray Pitkanen for the silver cup presented their son.

The property committee were asked to handle disposal of quarters formerly occupied by the ambulance and thawing machine.

Request for water service to a new home was refused until more favourable weather permits installation.

The department of municipal affairs wrote regarding request for advice on town planning and zoning.

A special meeting was held by council to authorize the borrowing of an additional \$10,000. to carry on town business pending tax collections.

J. H. Dawson of the Children's Aid Society met informally with council to discuss work and aims of the CAS. The full
