Clerk Skinner stated he had been informed the Ontario Municipal board does not approve 30 year debenture issues for high schools therefore a 20 year one must be prepared.

Kennel licences were turned down but the by-law covering dog licenses revised and rates lowered appreciably.

Bill Weaver requested permission for the Loyal Order of Moose to build and place a diving raft in Walker's Lake and for town property for winter storage. Several suggestions were offered Mr. Weaver and these will be investigated before a decision is made by council.

W.L. Wardrope and Associates advised that their engineer would be in Schreiber to make a field check of the water system.

The existing lease with the CPR covering ball field, ravine, and roadway south of the subway was surrendered in order to have a new one drawn up covering roadway alone. A new lease also was prepared for use of the ground for fire hall, garage and truck parking.

The Public School board and Canadian Legion wrote concerning the sale of Quebec Street.

A request was sent to the Dept. of Highways for laying of cold mulch on town streets.

The CPR's price for additional cemetery ground was considered prohibitive but the letter was filed for further consideration.
