# COUNCIL QUOTES

Deputy Reeve Des Evans-Smith presided last Wednesday at the regular meeting of the Terrace Bay Town Council due to the absence of the Reeve who was attending the Convention of Mayors and Reeves in the Lakehead. Secretary Mr. W.F. Strutt read the minutes of the previous meeting and all correspondence which was then dealt with.

A letter from their solicitor advised that Kimberly-Clark Corporation was deeding Block C and D, lot 205 required by zoning regulation for Park purposes in the Industrial area, therefore a motion was made to withdraw By-Law 138 designating five percent of the area for road allowance and park area.

A letter to the Reeve from Mr. John Ferrier, Mill Manager advised of the two ways Kimberly-Clark Corporation intended to aid the building of a town swimming pool. First they intended to make available the property adjacent to the Recreation Centre and secondly they would match contributions from the townspeople up to a maximum of Fifteen Thousand Dollars spread over a five year period.

By-Law 146 was read and passed setting the Tax rates as follows: General, Residential 11.39 mills, Commercial 12.66 mills, Town Area 28.66 mills, Public School 12.73 mills, Highschool 11.80 mills, Separate School 15.98 mills; making total rate of Public School Residential of 64.58 mills, Commercial 65.85 mills, Separate School Residential 67.83 mills and Commercial 69.10 mills. Dates for payment of taxes were established as July 31 and September 30th. A penalty of One-half of One percent per month will be imposed for late payment.

Deputy Reeve Evans-Smith reminded Councillors of their wish to present lapel pins to the All-star Bantam hockey team who had been the district champions. Council agreed to purchase a minimum of fifty pins for this type of award. The Deputy Reeve also suggested Councillors bring in recommendations for a replacement to Mr. Oren Mason on the High School Board to the next meeting of Council. He further recommended the Medical Officer of Health and School Nurse be invited to attend a meeting shortly.

Enquiries about the landscaping program were made by Councillor Fraser. Councillor Wellings felt they could get local bids on landscaping and also on the repairs to the Post Office Steps. Councillor Fraser also suggested as a Brewers Retail appeared to be coming into the District, they be advised of the availability of locating in this town.

Councillor Valiquette requested Municipal Council arrange a meeting with representatives of the Recreation Association Committee wherein they could discuss fully the realms of their authority. (Continued on Page 4)
