## POOL PAYMENTS BEGIN

Now that the Swimming Pool body is completed and work on the deck and surrounding area is under way, pool payments, as pledged by the citizens signing forms, will begin.

Mill employees who signed payroll deduction forms will have \$1.00 per month deducted commencing in September.

Those who signed direct-payment pledges will make payment at the Recreation Office in semi-annual installments.

THOSE WHO HAVE NOT YET SIGNED SHOULD NOTE THAT, UNLESS THEY DO SO BEFORE THE END OF SEPTEMBER, THEY WILL BE CLASSIFIED AS NON-MEMBERS FOR ONE FULL SWIMMING YEAR.

REMEMBER ..... POOL MEMBERSHIP FEES ARE AS FOLLOWS:-

1. Recreation Association Members who join the Pool Association on the pledge system -- \$12.00 per year.
2. Recreation Association Members who do NOT join on the pledge system - \$15.00 PER SEASON.
3. Non - Recreation Members who join for the swimming season - \$25.00 per season FOR SWIMMING PRIVILEGES ONLY.
4. Non - Recreation Members who do NOT join for the swimming season - 50¢ (adults) and 25¢ (children) PER INDIVIDUAL, each time they use the pool.

CONTROL OF MEMBERS AND NON-MEMBERS WILL BE CAREFULLY CHECKED BY THE POOL CASHIER, AS MEMBERS WILL HAVE NUMBERED AND COLOURED PLASTIC DISCS SIGNIFYING MEMBERSHIP. THESE MUST BE PRESENTED EACH TIME A SWIMMER ENTERS THE POOL AREA OR THE DAILY RATE WILL BE CHARGED.

THERE WILL BE A DISC FOR EACH PERSON IN "POOL MEMBER" FAMILIES.

It is evident that it will be far more advantageous to join the Pool Association on the pledge system. YOU HAVE ONLY UNTIL SEPTEMBER 30TH TO JOIN FOR THE 1962 -- 63 SEASON.

## G.M. MINARD ANNOUNCES ORGANIZATION CHANGES

The following organization changes, to become effective September 15th, 1962, have been announced by Mr. G.M. Minard.

Mr. Gordon G. Cosens relinquishes his responsibilities for Woodlands operations at Kapuskasing and LongLac to permit him to cultivate closer relationships with responsible authorities in Forestry branches of government; Pulp and Paper Research centres; universities; etc., and to advise the President on such vital matters.

Coincident with this change the responsibilities for both Woodlands and Mill operations at Kapuskasing will be centered in F.L. Flatt who becomes General Manager-Operations for Spruce Falls Power and Paper Company Limited, with headquarters at Kapuskasing.

Similarly, Woodlands operations (LongLac) of Kimberly-Clark Pulp and Paper Company Limited will be consolidated with Mill Operations (Terrace Bay) and J.C. Wig, formerly Director of Pulp Manufacturing in the parent Company, becomes General Manager-Operations for Kimberly-Clark Pulp and Paper Company Limited with headquarters at Toronto.

## CHAMBER OF COMMERCE ANNUAL MEETING DATE SET

Council members of the Terrace Bay Chamber of Commerce met on Monday evening in the Recreation Centre and one of the most important items discussed was the Annual Meeting and election of officers. The date decided upon is Thursday, October 4th at 7.30 P.M. in the small meeting room of the Recreation Centre.

General business of the meeting, conducted by President, C.E. Paget, included reading of the minutes and correspondence by Secretary Jack Kelty. The latter included letters to the annual meeting of various organizations with whom the local group are affiliated and an announcement from the Canadian Chamber of Commerce regarding a visit to Terrace Bay by Mr. H.T. Emery, representative of the Canadian Associated Chambers of Commerce (Organization Services) and the Ontario Chambers of Commerce. A luncheon meeting has been arranged on the occasion of his visit.

A letter from the Postal authorities outlined their policy for installing drop boxes. Council agreed that their refusal to install these in Terrace Bay was legitimate.

A letter from the Unemployment Insurance Commission pointed out (particularly to those in business) to whom benefits are available and the appalling abuse of said benefits by some.

Mr. Paget agreed to assume responsibility for pushing the Aguasabon Gorge project to a finish this Fall. He and one other Council member will attend a meeting of the Upper Lake Superior Travel Council (Cont'd Page 4)
